By the QUEEN. A PROCLAMATION.

VICTORIA R.

Whereas we have thought fit to order, that certain pieces of copper money should be coined, which should be called " half farthings," every such piece having for the obverse impression Our effigy, with the inscription, "Victoria D.G. Britanniar. Regina F.D," and for the reverse the words "half farthing," with the date of the year, surmounted by the royal crown, and below the united emblem of the rose, thistle and shamrock : and whereas pieces of the copper money of the description aforesaid have been coined at Our Mint, and will be coined there: We have therefore, with the advice of our Privy Council, thought fit to issue this Proclamation; and We do hereby declare, ordain, and command, that all pieces of copper money, so coined and to be comed as aforesaid, shall be current and lawful money of the Kingdom of Great Britain and Ireland, and shall pass and be received as current and lawful money of the said kingdom, every such half farthing piece as of the value of half a farthing of like lawful money: provided that no person shall be obliged to take more of such pieces in any one payment than shall be of the value of six perco.

Given at Our Court at Buckingham Palace, this thirteenth day of June, in the year of Our Lord one thousand eight hundred and forty two, and in the fifth year of Our reign.
