vious performance ever attempted in this place. Every thing was conducted with a circumspection suited to the character of the music, and becoming the place selected for hearing it. I cannot, at this time, ask for space to particularize all the individuals to whom the audience was indebted for this musical treat; but I must not omit to mention that the company was graced by the presence of Lady Colebrooke herself, who, with the Misses Colebrooke, in kind condescendence to wishes expressed, honored the entertainment by taking a part in it. The funds realized for the Infant School, after paying all expenses, I should think could not be much; this being but a repetition of the former pieces, and partaking more of the character of a free entertainment. It would be unjust to conclude these observations without a passing allusion to the condescending and benevolent spirit that has ever characterized His Excellency Sir William, during his administration, and Lady Colebrooke, in the commendable office of Charity, of which promoting Infant and Sabbath Schools may be fairly reckoned a part.
