REPORT OF THE COMMITTEE OF THE LADIES BENEVOLENT SOCIETY.

Before entering upon a detailed account of the proceedings of this Society during the short period of its operations-the Secretary begs to recall to the attention of the Committee, the objects proposed at its formation in November, 1841, which were-"to relieve the pressing wants of the destitute, and to enable the poor, as far as possible, to assist themselves, by furnishing them with the means of suitable employment."

How far the Committee have succeeded in the accomplishment

of these objects, the Report will enable you to judge.

Immediately upon the organization of the Society, the Town and moral, of all its poor inhabitants. The result of these visits, was the completion of a list of about 80 families, many of whom were in a state of great poverty, and some of actual suffering. In not a few cases it was found that whole families-parents and children-were without a bed to lie upon, or any other covering to protect them from the piercing cold of our winter nights, than the miserable clothing they wore during the day. The Fathers, out of all employment, and the Mothers, unable to procure such work as they were capable of performing.

A supply of coarse covers to fill with Straw-a number of blankets and other bedding-and a quantity of suitable materials for clothing, were at once purchased, and the latter, after being cut out and prepared by a Committee of Ladies appointed for the purpose, was given to the poor women to make up at a moderate price.

A communication was opened without loss of time, with the Commissioners of the Alms House, upon the practicability of furnishing work for the men-and in pursuance of the resolutions of that body, work was provided for a considerable number in breaking stones.

With this resource, it was thought justifiable to withold relief from all applicants whose husbands refused to avail themselves of this means of providing for their families, unless a certificate was obtained from Doctor Toldervey, signifying the inability of the parties to undertake such work.

In order to assist the designs of the Committee in more effectually providing for Medical attendance, and proper care for the sick, the Cholera Hospital was placed at the disposal of His Excellency the Lieutenant Governor, by the Board of Magistrates, for the reception of indoor patients-and which was titted up for their comfortable accommodation, partly from the funds of the Society, under the judicious direction of Doctor Toldervey, and six persons have at different times been placed in it by the Society, under his care, exclusive of many others who have availed themselves of its advantages-whose humane and zealous services in these and many other instances, the Society gratefully acknowledges.

Having adopted these measures for the immediate relief of their my Heirs by Decd. bodily wants, the attention of the Committee was next directed to the moral improvement of the poor; and as they felt satisfied that

the most certain method of accomplishing this, was to commence with the instruction of the young, an object contemplated by the Society at its first General Meeting, every exertion was made to effect the establishment of an Infant School for their benefit; and we have the satisfaction to inform you, that an Institution is now in successful operation, under the management of Miss Fayerweather, who for six years taught a School upon this system at St. John, and who made it over to the charge of her sister, to enable her to come to Fredericton. This School was opened on the 22d of March, in presence of His Excellency the Lieutenant Governor, Lady Colebrooke and family, the Venerable the Archdeacon, His Honor the Speaker of the Assembly, the Solicitor General, and several Members of both branches of the Legislature, and other persons of respectability, the number of children collected was sixty, who were from the most destitute class of the community, and a very warm and general interest was excited in their behalf, an interest which, on the part of the Legislature, was promptly manifested by a grant of fifty pounds, in aid of the School; of this sum, twenty seven pounds has been expended in fitting up a Room, providing fuel, &c., and the balance remains towards the payment of the Teacher's Salary.

The design of the Society in establishing the Infant School was to assist the parents by relieving them during the day from the charge of their young children, thus enabling them to go out to their work, and to promote the welfare of their children, by forming them to habits of order and industry, and giving them early im-

pressions of correct moral and religious principles.

Owing to some misapprehension of the system pursued in the School, (which has been strictly conformable to the manual of instruction in Infant Schools for children of all Denominations in England,) the children of Roman Catholic parents have been withdrawn, but the vacancies have since been filled up, and the numerous applications for admission indicate that another School could with advantage be established in this town.
