And be it enacted, That all and every Grant, Lease or other assurance which, during the continuance of this Act, shall be made or granted by His Majesty, His Heirs or Successors, of any Lands, Tenements, Rents, Woods, Mines, Royalties, Revenues, or other hereditaments within this Province, now belonging or hereafter to belong to His Majesty, His Heirs or Successors, whereby any estate or interest whatsoever in Law or equity shall or may pass from His Majesty, His Heirs or Successors, save and except as hereinafter provided, shall be utterly void and of none effect unless such Grant, Lease or assurance be made upon sale or rent to the highest Bidder at Public Auction in this Province, due notice having been first given thereof in the Royal Gazette, and unless all such sums of money and rents as may be payable in consideration of such Grant, Lease or assurance be made payable to His Majesty, His Heirs or Successors during the whole term or time of the continuance thereof respectively."
