AT THE COURT AT BUCKINGHAM PALACE,

The 11th of August, 1842.

PRESENT:

HEREAS the Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did, in the months of March and April, 1842, pass twenty nine Acts, which have been transmitted, entitled as follows :---

No. 1392. An Act to authorize the Justices of the Peace for the County of Charlotte, to make regulations for the Market Wharf, in the Parish of St. Stephen.

No. 1393. An Act to repeal an Act, intituled "An Act to prevent the taking of Fish, in the different Harbours and Rivers of this Province, with Drift Nets," so far as the same relates to the County of Westmorland.

No. 1394. An Act to extend the provisions of an Act, intituled "An Act to repeal the Laws now in force, for appointing Firewards, and for the better extinguishing of Fires in the Town of St. Andrews, and to make regulations more suitable to the said Town, and for other purposes therein mentioned," to the Towns of

and the better extinguishment of Fires, in a part of the Parish of St. Stephens, in the County of Charlotte, therein mentioned.

No. 1407. An Act to erect the upper part of the Parish of Wakefield, in the County of Carleton, into a separate and distinct Town or Parish.

No. 1409. An Act relating to the Market of Fredericton.

No. 1410. An Act to authorze the Justices of the Peace for the Count of Northumberland, to levy an assessment to discharge the debts due by the said County.

No. 1412. An Act to authorize Her Majesty's Juctices of the Peace for the County of Goucester, to assess the said County for the payment of the County debt.

No. 1413. An Act to continue the Acts relating to Highways.

No. 1414. An Act to repeal certain parts of an Act, intituled "An Act to authorize the appointment of Commissioners, to lay out a Street or Highway through the Town of Chatham, and to establish and regulate public Landings in the said Town," and to make other provisions in lieu thereof.

No. 1416. An Act further to facilitate the means of supplying the City of St. John with water, by transferring the Water Works of the St. John Water Company to the Mayor, Aldermen, and Commonalty of the City of St. John.

No. 1417. An Act to authorize the Justices of the Peace for the County of Sunbury to make rules and regulations for protecting the public use of the Draw in the Bridge over the River Oromocto.

No. 1418. An Act to revive an Act, intituled "An Act for regulating the Salmon Fisheries in the County of Gloucester."

No. 1420. An Act to incorporate the St. Andrews Marine Assurance Company.

No. 1426. An Act to appropriate a part of the Public Revenue

Dalhousie and Campbelltown, in the County of Restigouche.

No. 1395. An Act to authorize the Justices of the Peace for the County of York, to levey a further assessment, for the purpose of paying off the debt due on the erection of a new Gaol, in the said County.

No. 1396. An Act to continue an Act, intituled "An Act to provide for the erection of Fences with Gates across the Highways on Deer Island, in the Parish of West Isles, in the County of Charlotte.

No. 1397. An Act to establish the line of Road from Oak Bay, in the County of Charlotte, to the mouth of Eel River, in the County of York, as one of the Great Roads of Communication in this Province.

No. 1398. An Act to repeal the Act to prevent disorderly riding or driving on Public Bridges and make other provisions in lieu thereof.

No. 1399. An Act to authorize the Justices of the Peace in and for King's County, to raise a sum of money for paying the Contractors for building a Gaol in the said County.

No. 1400. An Act to authorize Commissioners for taking Affidavits in Causes pending in the Supreme Court to take Affidavits in Causes pending in the several Inferior Courts of Common Pleas for the several Counties in this Province.

No. 1401. An Act to alter the division line of the Parishes of Douglas and Queensbury, in the County of York.

No. 1402. An Act to authorize the Justices of the Peace for Queen's County, to levy an assessment to pay off the County debt.

No. 1403. An Act to amend an Act, intituled "An Act to repeal all the Acts regulating Tavern Keepers and Retailers, and to make other provisions in lieu thereof."

No. 1404. An Act to authorize Her Majesty's Justices of the Peace for the County of Charlotte, to levy an assessment to pay off the County debt.

No. 1405 An Act to authorize the Magistrates of the County of Restigouche, to levy an assessment upon the Inhabitants of the said County to pay off the County debt.

to the payment of the ordinary services of the Province.

No. 1427. An Act to appropriate a part of the Public Revenue for the services therein mentioned.

No. 1428. An Act to provide for opening and repairing Roads, and erecting Bridges throughout the Province.

No. 1430. An Act to incorporate the St. Stephens' Marine Assurance Company.

And whereas the said acts have been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council, appointed for the consideration of all matters relating to Trade and Foreign Plantations, and the said Committee have reported as their opinion to Her Majesty, that the said Acts should be left to their operation; Her Majesty was thereupon this day pleased, by and with the advice of her Privy Council, to approve the said report : Whereof the Governor, Lieutenant Governor or Commander in Chief for the time being of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
