VHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick with the Council and Assembly of the said Province, did, in the month of March, 1841, pass one Act, which has been transmitted, entitled as follows, viz:-

No. 1345. An Act in further amendment of the Law;

And whereas the said Act has been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council, appointed for the consideration of all matters relating to Trade and Foreign Plantations, and the said Committee have reported as their opinion to Her Majesty, that the said Act should be left to its operation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said report: Whereof the Governor, Lieutenant Governor or Commander in Chief for the time being of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and (CIRCULAR.) govern themselves accordingly.

Downing Street, April 21, 1842.

SIR,-I have received your Despatch No. 31, of the 30th ult., enclosing a Petition to the Queen, from the Magistrates, Merchants, and other Inhabitants of the County of York, praying that no change may be made in the scale of Duties on wood and other articles, which may affect the trade of New Brunswick with Great Britain and Ireland, and with the British West Indies.

I have to instruct you to acquaint the Petitioners, that I have had the honor to lay their Petition before the Queen, and that Her Majesty was pleased to receive it very graciously.

Your Despatch with the Petition has been referred by Her Majesty's command, for the consideration of the Lords of the Committee of Privy Council for Trade.

A PROCLAMATION.

WHEREAS by several Proclamations heretofore issued, bearing date the twenty ninth day of July, one thousand eight hundred and thirty seven, the twenty second day of October, one thousand eight hundred and thirty nine, and the twenty ninth day of June, one thousand eight hundred and forty one, the cutting of Timber in the Disputed Territory, pending the Settlement of the Boundary, was prohibited; and whereas it has been represented to me that notwithstanding such prohibitions, large quantities of Timber have been cut in and upon that Territory during the last year,-It is hereby publicly made known to all persons concerned, that if any part of the Timber so cut should be brought into the River Saint John, it will be liable to seizure; and all Seizing Officers, Magistrates and other persons on whom it may depend, are hereby required to be vigilant in aiding and assisting to prevent its introduction.

Given under my Hand and Seal at Fredericton, the ninth day of April, in the year of our Lord one thousand eight hundred and forty two, and in the fifth year of Her Majesty's Reign.

SIR--My attention has been called by a variety of recent instances to the inconvenience arising to the Public Service from the lengthened leaves of absence granted to Civil Officers in the different Colonies, and, in some instances, to those who have applied for, and received, an extended leave of absence without any intention of again resuming their duties.

In order in some degree to remedy this inconvenience, I have to request that you will, in future, abstain from accompanying your leave of absence to any Officer with a recommendation for extension of leave by the Secretary of State. Such recommendations make it very difficult to disappoint the expectations which they have raised; while the Public Service may sometimes be injuriously affected by a compliance with them.

I have further deemed it necessary to lay down a general rule, that, for the future, the half Salary for the last half of the term of leave originally granted to the Colonial Officer shall only be received on the return of such Officer to his duty.
