By His Excellency Lieutenant Colonel SIR WILLIAM ] to improve the condition of Agriculture and the Household Arts, within the districts of its contemplated action.

> 2. The Society shall consist of those who shall signify in writing or otherwise, their desire to become Members, and shall pay the sum of 5s. on admission, and not less than 5s. annually, or the payment of 50s. shall exempt the doner from annual contributions.

> 3. Officers of similar Societies in other Counties of the Province, to be ex-officio honorary Members and visitors at the Board of this Society.

> 4. The directory or management of this Society shall be vested in a President, Vice-President, Directors, Secretary, and Treasurer. 5. The Secretary shall keep the record of the proceedings of the Society, and correspond with other Societies and Individuals, as may be requisite in furtherance of the objects of the Board, &c.

> 6. The Treasurer shall keep the Funds of the Society, and disburse them by order of the President or Vice-Fresident, or in their absence, by two Directors, countersigned by the Secretary; and shall keep and report the receipt and expenditure of the Funds of the Society at the Annual Meeting, to be held in October.

> 7. The Executive Board of Officers, or a Committee thereof, shall take charge of, loan to Members, and preserve Books, Models, &c.; and to sell Seeds and Plants to them at cost and charges, or distribute them gratuitiously to poor and deserving settlers in the Country. They shall also have charge of all communications designed or calculated for publication, and as may be deemed expedient, shall collect, arrange and publish the same in such manner and form as they shall deem best calculated to promote the objects of the Society: and also be a medium of communication with distant Members or with sister Societies in other Countries.

At a Meeting of the Board of Directors of the Stint John Agricultural and Horticultural Society, held on the 21st April, the Honorable CHARLES SIMONDS, President, in the Chair, on motion therefrom, Resolved, That Mr. WEDDERBURN, Dr. COOK, and Mr. DUNN, be a Committee to draw up and submit Rules and Regulations for said Society :-

#### RULES AND REGULATIONS OF THE SAINT JOHN CITY AND COUNTY AGRICULTURAL SOCIETY.

No. 1. This Society shall be known by the name of the Saint John City and County Agricultural Society; its objects shall be cants may have defrayed the expense of survey, or made improvements upon 20. 20.

8. There shall be an Annual General Meeting of the Society held in the City of Saint John on 1st Tuesday of October in each and every year, for the transaction of general business, election of Officers, and such other measures as may be deemed necessary for Agricultural interests.

9. That Four Markets shall be held for the purchase and sale of all kinds of Live Stock, Grain, Roots, and such other produce of Husbandry as may be deemed expedient and advantageous to thus offer for sale. The Markets to be held in the City on the 1st Tuesday in April, ditto July, ditto October, ditto December, in each year.

10. That to encourage the exertions of the humble Emigrant settler, and others in remote or wilderness districts, Committees formed of two Members, resident in the different Parishes of the Country, visit their locations, at such time as their judgment may suggest-inspect their location and condition, with any other matter which may offer itself to the discretionary consideration of the Visitors, and report the same to this Board, who will take such means as may come under its power to reward their past industry, and stimulate their future exertions.
