II. And be it enacted, That whosoever shall rob any person, and at the time Punishment of of, or immediately before or immediately after such robbery shall stab, cut or with cutting, &c. wound any person, shall be guilty of Felony, and being convicted thereof shall suffer death.

III. And be it enacted, That whosoever shall, being armed with any offensive of robbery attended weapon or instrument, rob or assault with intent to rob any person, or shall together with one or more person or persons, rob, or assault with intent to rob any person, or shall rob any person, and at the time of, or immediately before or immediately after such robbery, shall beat, strike or use any other personal violence to any person shall be guilty of Felony, and being convicted thereof shall be liable, at the discretion of the Court, to be imprisoned for the term of the natural life of such offender, or for any term not less than three years.

IV. And be it enacted, That whosoever shall accuse or threaten to accuse any Punishment for obperson of the abominable crime of Buggery committed either with mankind or taking property by threat of accusing with beast, or of any assault with intent to commit the said abominable crime, or of any attempt or endeavour to commit the said abominable crime, or of making or offering any solicitation, persuasion, promise or threat to any person, whereby to move or induce such person to commit or permit the said abominable crime, with a view or intent in any of the cases aforesaid, to extort or gain from such person, and shall by intimidating such person by such accusation or threat, extort or gain from such person any property shall be guilty of Felony, and being convicted thereof shall be liable, at the discretion of the Court, to be imprisoned for the term of the natural life of such offender, or for any term not less than three years.

V. And be it enacted, That whosoever shall rob any person shall be liable, at Punishment the discretion of the Court, to be imprisoned for any term not exceeding fourteen person. years nor less than three years.

VI. And be it enacted, That whosoever shall assault any person with intent to Punishment for rob shall be guilty of Felony, and being convicted thereof shall (save and except assault with intent in the cases where a greater punishment is provided by this Act) be liable to be imprisoned for any term not exceeding three years.

VII. And be it enacted, That whosoever shall with menaces or by force demand Attempting to ob any property of any person with intent to steal the same shall be guilty of Felony, tain property by menace. and being convicted thereof shall be liable to be imprisoned for any term not exceeding three years.

VIII. And be it enacted, That whosoever shall plunder or steal any part of Punishment for any Ship or Vessel which shall be in distress, or wrecked, stranded, or cast on shore, or any goods, merchandize or articles of any kind belonging to such Ship or Vessel, and being convicted thereof shall be liable, at the discretion of the Court, to be imprisoned for any term not exceeding fourteen years nor less than three years.

IX. And be it enacted, That in the case of every Felony punishable under Punishment for acthis Act, every Principal in the second degree and every Accessory before the fact, shall be punishable with death, or otherwise in the same manner as the Principal in the first degree is by this Act punishable, and every Accessory after the fact, to any Felony punishable under this Act (except only a receiver of stolen property) shall on conviction be liable to be imprisoned for any term not exceeding two years.

X. And be it enacted, That when any person shall be convicted of any offence Punishment by impunishable under this Act for which imprisonment may be awarded, it shall be prisonment may be awarded. lawful for the Court to sentence the offender to be imprisoned or to be imprisoned and kept to hard labour in the Common Gaol or House of Correction or the or both. Provincial Penitentiary, and also to direct that the offender shall be kept in solitary confinement for any portion or portions of such imprisonment, or of such imprisonment with hard labour not exceeding one month at any one time, and not exceeding three months in any one year, as to the Court in its discretion shall seem meet.
