I have the honor to acquaint von, that an Order was on the 10th instant made by the Q een in Council, for extending to Dalhousie, on the River Restigouche, in New Branswick, the privileges of a Free Fort, and that the requisite instructions have been given by the Lords of the Treasury to the Commissioners of Customs, for carrying that Order into effect.

AT THE COURT AT BUCKINGHAM PALACE,

The 10th day of June, 1843.

PRESENT:

The Queen's Most Excellent Majesty in Council.

HEREAS by an Act passed in the Session of Parliament holden in the 3rd and 4th years of the reign of His late Majesty King WILLIAM the Fourth, intituled "An Act to regulate the Trade of the Pritish Possessions Abroad," it was amongst other things enacted, that no goods should be imported into, nor should any goods, except the produce of the fisheries in Brit sh ships, be exported from any of the British Possessions in America by sea, from or to any place other than the United Kingdom, or some other of such Possessions, excepting to or from the several Ports in such Possessions called free Perts, enumerated or described in the Table in the said Act contained: And it was thereby provided, that if His Majesty should deem it expedient to extend the provisions of the said Act to any Port or Ports, not enumerated in the said Table, it should be lawful for the Majesty by Order in Council, to extend the provisions of the said Act to such Port or Ports; and that from and after the day mentioned in such Order in Council, all the privileges and advantages of the said Act, and all the provisions, penalties and forfeitures therein contained, subject nevertheless to the limitations and restrictions therein after provided, should extend, and be deemed and construed to extend to any such Port or Ports respectively, as fully as if the same had been inserted, and enumerated in the said Table, at the time of passing the said Act. And whereas Her Majesty doth deem it expedient to extend the before mentioned provisions of the said Act, respecting such free Ports, to the Port of Dalhousie, on the River Resti-

By His Excellency Sir WILLIAM MACBEAN GEORGE gouche, in the Province of New Brunswick; -Now, therefore, under and by virtue of the said Act of Parliament, and in exercise of the powers thereby in Her Majesty in Council in that behalf vested, Her Majesty, by and with the advice of Her Privy Conneil, doth order, and it is hereby ordered accordingly, that from and after the 1st day of August next, the provisions of the said Act, and of any Act or Acts amending the same, as far as such provisions relate to the free Ports respectively mentioned in the said recited Act. shall be, and the same are hereby extended to the Port of Dalhouprorogned to Tuesday the twenty seventh day of June instant, sie, on the River Restigonche, in the Province of New Brunswick; and that from and after the said 1st day o' August next, all the privileges and advantages by the said recited Act, and by any Act or Acts amending the same, conferred upon the free Ports mentioned Given under my Hand and Seal at Fredericton, the sixteenth in the said recited Act, and all the provisions, penalties and forfeiday of June, in the year of our Lord one thousand eight tures in the said Act contained, subject to the limitations and rehundred and forty three, and in the sixth year of Her strictions therein provided, shall extend to the said Port of Dalhousie, as fully and effectually as if such Port had been inserted and enumerated in the said Table, at the time of passing the said recited
