CHARLOTTE Town, P. E. I., March 28.—Some serious disturbances having taken place in King's County, the attention of the Government has been called thereto, and we have reason to believe that very prompt measures have been resolved upon with a view to prevent their recurrence. The particulars have not yet been made public, but it is sufficient to state that on the 17th instant, a very large assemblage of people, said to number 300, took place on Township 45, and forcibly reinstated a person named Haney, into the possession of a house and farm, from which he had been legally ejected; and a Surveyor who had been employed to lay off lands for new settlers, had been compelled to discontinue operations and abandon his work. On the night of Friday last, the Dwelling House of Lawrence Macguire, of Lot 45, a person employed by the proprietor to protect timber, was consumed by fire kindled with out much doubt, by the torch of an incendiary, as threats to that effect were given to Macguire on the day of the riot.

A proclamation offering £200 for the apprehention and conviction of the perpetrators, will be found in another column, which it is to be hoped will have the desired effect. It is impossible to view these high handed measures with unconcern. At the very time that the Legislature are proposing to concert some efficient inediation between the proprietors and the pocrest classes of the tenantry, the misguided people are induced to infringe the law which bind society together, and thus eventually bring ruin upon their own heads. We have reason to be thankful that there is a firm disposition in the Executive to enforce the majesty of the law and to crush any thing like incipient insurrection. - Gazette.

YORK GENERAL SESSIONS.

JANUARY TERM, 1843.

HEREAS the method heretofore practised in keeping and making up the County Accounts is not sufficiently clear and explicit; therefore it is

Ordered, That hereafter the following Rules in keeping and

making up the County Accounts be observed :-

That all persons, whether salaried officers or others, having claims upon the County, do file with the Accountant on or by the first Tuesday of each year, a Bill of Particulars of their several and respective claims, made up to and to include the last day of the then preceding year, 31st December.

That the Accountant do file with the Clerk on or by the first day of the opening of the Court in January, a schedule of all claims filed with him, agreeably to the foregoing Rale, setting forth the following particulars :- name of claimant, amount claimed, and nature of services rendered, shewing also the sum total of the whole, together with an estimate of the probable ordinary income, exclusive of assessments of the then current year.

That the Treasurer make up all his Accounts to the close of the year; that they in every case shew the actual state of the monetary affairs of the County, as they may happen to be at that time, namely, the close of the 31st day of December; that should there be any claims of the then current year remaining unpaid, either to or by the County, he do furnish along with his Accounts a particular statement thereof.

That the Treasurer keep a separate and distinct account of all the expenses of the County Gaol, including the keeper's salary; as also a separate account of the amount paid to the different Constables; the sum total of each of their account, to be entered in the General Account Corrent. All the County Accounts to be filed with the Clerk on or by the first day of the January Term, and to be referred to a Committee to audit, who shall carefully examine the same and report thereon on the first day of the June Term following.

That all the County Accounts be entered and kept in suitable Books, well bound, the Accounts to be kept regularly posted up, so as at all times to exhibit the true state of the monetary affairs of the County; all such Books to be laid on the Clerk's table during the sitting of the Court in January and June Terms, for the information and inspection of the Members of the Court and the Grand Jury.

That the Treasurer keep a separate account of all fines and forfeitures received by him, mentioning from whom received, by whom and for what offence levied, and name and residence of the offending party; all fines and forfeitures payable to the County, to be by the numerous competitors for office. The Election was warmly paid over to the County Treasurer, within one month after the same shall have been actually levied and paid by the offender.

All the County Accounts to exhibit the actual amount of receipts

and expenditures of the County, within each year.
