

FORAGE.

For one year from the 1st January, 1844, for the Horses of Officers belonging to the Garrisons of Saint John and Fredericton. The Tenders to state the rates at which the ration, consisting of 10 lbs. Oats, 14 lbs. Hay, and 6 lbs.
