The U.S. Congress adjourned at 4 o'clock on the morning of the 4th inst. The Washington correspondent of the New York Herald, of that date, says: -

"Yesterday, Friday, the Senate spent nearly all day in Executive Session ; they met at 12 at noon, and are now, half-past three o'clock, Saturday morning, still in Executive Session. They passed the bill to send a minister to China, restricting the salary to \$9000 a year, and compelling the President to name him at the present session. They were all day in Executive session on minor appointments; and after tea, or rather after brandy and water, took up the nomination of Wise as Minister to France. This they rejected, 24 to 12. They then took up and rejected Cushing, as Secretary of the Treasury, 27 to 19. The President sent their names in three several times, and three times they were rejected. This has created great excitement here.

The President then sent in John C. Spencer as Secretary of the Treasury, and Mr. Everett as Minister to China. After considerable debate, they were both confirmed."

4 o'clock, Saturday Morning .- The Senate has just adjourned. No new nominations were sent in for Secretary of War, or Minister to France or Minister to England.
