Degree of Bachelor of Arts; "Be it enacted and declared, for the purpose of extending the benifits of the University, that Students who shall have been duly matriculated, and shall have satisfactorily passed an Examination at the College at the end of Trinity Term for three successive years, and also the appointed Examination for the Degree of Bachelor of Arts, presenting on these several occasions satisfactory testimonials of their moral character and good conduct, may without Academical Residence, or the performance of other Academical Exercises, be admitted to the said Degree :"-
