Debtors are maintained by themselves or the Creditors: Criminals by the County, at an average cost of about 3s. 10d. stg., per week.

There is one Gaol in each County, under the jurisdiction and superintendence of the Sheriff; but the Gaols are on a much more limited scale than those contemplated in the Returns and Questions. There is no established Prison discipline nor fixed system of management, both of which have hitherto been chiefly left to the judgment and humanity of the Sheriffs, who have in no instance as yet been complained of.
