THEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Conncil and Assembly of the said Province, did, in the month of April, 1844, pass an Act, which has been transmitted, entitled as follows, viz:

No. 1525. An Act further to facilitate the means of supplying the City of St. John with Water.

And whereas the said Act has been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council appointed for the consideration of all matters relating to Trade and Foreign Plantations, and the said Committee have reported as their opinion to Her Majesty, that the said Act should be left to its operation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said Report : Whereof the Governor, Lieutenant Governor, or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice C. GREVILLE. and govern themselves accordingly.

DUBLIC Notice is hereby given, That all persons making application for the purchase of Crown Lands will in future be required to state in their Petitions whether the Lands have been improved, and that they must adhere to the printed forms which have been circulated, to which a column is to be added to include this information.
