ANNO SEPTIMO VICTORIÆ REGINÆ.

CAP. XXIX.

An Act to establish the value of certain British Coins in this Province and to amend the Acts relating to the establishment of a Legal Tender.

Passed 13th April 1844.

E it enacted by the Lieutenant Governor, Legislative Council and Assem- 58 G. 3, c. 23, s. 1 bly, That the first and second sections of an Act made and passed in the fifty eighth year of the Reign of His Majesty King George the Third, intituled An Act in addition to an Act, intituled 'An Act for establishing a Tender in all payments to be made in this Province;' also so much of an Act made and passed in the thirty sixth year of the Reign of His Majesty King George the Third, 36 G. 3, c. 0, in part intituled An Act for establishing a Tender in all payments to be made in this Province, as shall be contrary to any of the provisions of this Act, be and the same are hereby repealed.

II. Be it enacted, That from and after the passing of this Act, the several Coins Value of English Sovereign and hereinafter enumerated, and the several respective aliquot parts of the several Crown, defined. respective Coins hereinaster enumerated, shall pass current and be received and be a Legal Tender in all payments to be made in this Province, at the following rates and valuation: The English Sovereign at one pound four shillings currency; the English Crown at six shillings currency.

CAP. XXX.

An Act further to continue an Act to provide for the prompt payment of all demands upon the Provincial Treasury.

Passed 13th April 1844.

THEREAS in and by virtue of the provisions of an Act made and passed Preamble. 'in the second year of the Reign of Her present Majesty, intituled 2 v. c. 44. An Act to provide for the prompt payment of all demands upon the Provincial 'Treasury, a certain agreement was made and entered into by and between the 'Treasurer of the Province and the Bank of New Brunswick, for the purposes of ' the said Act, which has been continued to the present time; And whereas the 'aforesaid Act will expire on the first day of April which will be in the year of 'our Lord one thousand eight hundred and forty five, and it is considered

'necessary to continue the provisions thereof under certain conditions;' Be it therefore enacted by the Lieutenant Governor, Legislative Council and Assembly, That an Act made and passed in the second year of Her Majesty's 2 V. c. 44, con-Reign, intituled An Act to provide for the prompt payment of all demands upon the Provincial Treasury, be and the same is hereby continued for the further term of five years from the first day of April one thousand eight hundred and forty five, and that the Treasurer of the Province be and he is hereby authorized and Provincial Treaempowered to continue the agreement at present existing with the said Bank of surer authorized to New Brunswick during the continuance of this Act; Provided always, that no with the Bank of New Brunswick. greater rate of Interest than five and one half per cent. be hereafter paid on the said agreement.
