A PROCLAMATION.

THEREAS it appears from an Inquest held before William Bayard, M. D., Coroner of our Lady the Queen, for the City of Saint John, on the sixteenth day of May instant, on view of the body of James Magrath, then and there lying dead, it was found that some person or persons, to the said Jurors unknown, with force and arms, in the Parish of Portland, in the County of Saint John, in and upon the said James Magrath, in the peace of God and our Lady the Queen, then and there being, did feloniously, wilfully and of his or their malice aforethought, did make an assault, and then and there did shoot, by means whereof the said James Magrath died:

I do therefore publish this Proclamation, and do hereby offer a Reward of Fifty Pounds to whomsoever shall give such information to Her Majesty's Attorney General, of the person or persons by whom the above offence was committed, as may lead to the apprehension and conviction of the Offender or Offenders.

Downing Street, 30th March, 1845.

(No. 288.) Sir, -I have the honor to acquaint you, for your information and guidance, that Her Majesty's Government have had under their consideration the claim of Citizens of the United States to fish in the Bay of Fundy, a claim which has hitherto been resisted on the ground that that Bay is included within the British Possessions.

Her Majesty's Government feel satisfied that the Bay of Fundy has been rightly claimed by Great Britain as a Bay, within the Treaty of 1818; but they conceive that the relaxation of the exercise of that right would be attended with mutual advantage to both countries;

By His Excellency Sir WILLIAM MACBEAN GEORGE | - to the United States, as conferring a material benefit on their Fishing Trade, and to Great Britain and the United States conjointly and equally, by the removal of a fertile source of disagreement between them. It has accordingly been announced to the United States Government, that American Citizens would henceforward be allowed to fish in any part of the Bay of Fundy, provided they do not approach, except in the cases specified in the Treaty of 1818, within three miles of the entrance of any Bay on the Coast of Nova Scotia or New Brunswick.

NOTICE TO MARINERS.

Floating Light off the Roman Rocks in False Bay.

Rear Admiral the Honorable Josceline Percy, C. B., Commander in Chief of Her Majesty's Ships and Vessels on the Cape of Good Hope Station, hereby gives Notice, that, in pursuance of Instructions from the Lords Commissioners of the Admiralty, a Floating Light is moored off the Roman Rocks, in 7½ fathoms water, distant therefrom one cable's length, due North, (by Compass.)

It is a bright revolving Light, 37 feet above the level of the Sea, and may be seen in clear weather at a distance of 10 miles from the ship's deck. It will be lighted at Sun-set all the year round, and extinguished half-an-hour after day light.

The Light Vessel is painted Red, and during day light will hoist a Red Flag when a Sail is in sight.

The following remarks made by Mr. Brown, Master of H
