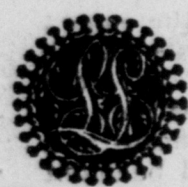

A PROCLAMATION.

WHEREAS the General Assembly of this Province stands prorogued to the third Tuesday in this instant month of December; I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to Wednesday the twenty ninth day of January next, then to meet at Fredericton for dispatch of Business.

Given under my Hand and Seal at Fredericton, the sixth day of December, in the year of our Lord one thousand eight hundred and forty four, and in the eighth year of Her Majesty's Reign.

Madawaska, 24th December, 1844.

SIR,—I have the honor to acknowledge the receipt of your Letter of the 20th instant, with a small parcel from His Excellency containing Vaccine Lymph, and shall proceed in accordance without delay, in company with Messieurs Rice and Coombes, to that part of the Settlement where the Small Pox has made its appearance, for the purpose of Vaccinating the Inhabitants, and take such other means as are made due, most expedient to prevent the spreading of the Infection.

Fort Kent, Fish River, Upper Saint John,
28th December, 1844.

SIR,—I have had the honor to day to receive your Letter of the 20th instant, in which you inform me that His Excellency the Lieutenant Governor has been so kind as to forward me a supply of Vaccine Lymph for the use of the Medical Officer at this Post.

Be pleased to present my thanks to His Excellency for his kindness, and say to him, that as soon as the Medical Officer at this Post was called on, he visited the person who brought the Small Pox into this neighbourhood, and gave such directions as were necessary for the treatment of the disease. We immediately took measures to procure a supply of Vaccine Lymph, on the receipt of which, Assistant Surgeon Wetherspoon went to Webster, in New Brunswick, and vaccinated the family in the house in which the disease made its appearance, and in the house above and below, in all twenty one persons, leaving directions how to proceed when the matter could be procured from those he had vaccinated. I am happy to say that nearly one hundred and fifty persons on both sides of the River Saint John have been vaccinated, and I conceive that the Small Pox has been effectually checked, provided the most ordinary care be taken.

Assure His Excellency, that should an occasion occur, our labours in the cause of humanity will not be limited to this side the Saint John's River.
