**W**HEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did, in the month of March last, pass seven Acts, which have been transmitted, entitled as follows, viz:—

No. 1587. An Act to incorporate sundry persons by the name of the Globe Assurance Company.

No. 1592. An Act to incorporate the Saint Andrews Whale Fishing Company.

No. 1604. An Act for regulating the Salmon Fisheries in the County of Restigouche.

No. 1620. An Act to regulate the Survey and Exportation of Lumber.

No. 1625. An Act to repeal an Act, intituled "An Act to amend an Act to provide for maintaining Light Houses within the Bay of Fundy," and to substitute other enactments in lieu thereof.

No. 1626. An Act to make provision for the regulation of Seamen shipped on board of, or belonging to all Ships or Vessels registered in or belonging to the Province of New Brunswick, while such Ships or Vessels shall be within the precincts thereof.

No. 1634. An Act to amend an Act to repeal an Act, intituled "An Act to provide for the greater safety of Passengers on board Steam Boats, and to make further provision in lieu thereof."

And whereas the said Acts have been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council, appointed for the consideration of all matters relating to Trade and Foreign Plantations; and the said Committee have reported, as their opinion, to Her Majesty, that the said Acts should be left to their operation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said Report: Whereof the Governor, Lieutenant Governor or Commander in Chief for the time being of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

CAP. IV.

An Act to continue for Three Years the Duties on Profits arising from Property, Professions, Trades, and Offices. [5th April, 1845.]

MOST GRACIOUS SOVEREIGN,

**W**HEREAS by an Act passed in the Fifth and Sixth Years of Your Majesty's Reign, intituled *An Act for granting to Her Majesty Duties on Profits arising from Property, Professions, Trades, and Offices, until the Sixth day of April One thousand eight hundred and forty five*, certain Rates and Duties arising from Property, Professions, Trades, and Offices, were granted to Your Majesty for a Term therein limited, which will expire after the Fifth Day of April one thousand eight hundred and forty five: We, Your Majesty's most dutiful and loyal Subjects, the Commons of the United Kingdom of Great Britain and Ireland, in Parliament assembled, towards raising the necessary Supplies to defray Your Majesty's public Expenses, have freely and voluntarily resolved to continue the said Rates and Duties, and to grant the same to Your Majesty for the Period hereinafter mentioned; and do most humbly beseech Your Majesty that it may be enacted; and be it enacted by the Queen's Most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That the several Rates and Duties by the said recited Act granted shall be and the same are hereby continued, and shall be charged, raised, levied, collected and paid, unto and for the Use of Her Majesty, Her Heirs and Successors, for the Term of Three Years, to be computed from the Fifth Day of April one thousand eight hundred and forty-five,
