Given under my Hand and Seal at Fredericton, the ninth day of June, in the year of our Lord one thousand eight hundred and forty five, and in the eighth year of Her Majesty's Reign.

A PROCLAMATION.

HEREAS it appears from an Inquest held before William Bayard, M. D., Coroner of our Lady the Queen, for the City of Saint John, on the sixteenth day of May instant, on view of the body of James Magrath, then and there lying dead, it was found that some person or persons, to the said Jurors unknown, with force and arms, in the Parish of Portland, in the County of Saint John, in and upon the said James Magrath, in the peace of God and our Lady the Queen, then and there being, did feloniously, wilfully and of his or their malice aforethought, did make an assault, and then and there did shoot, by means whereof the said James Magrath died:

I do therefore publish this Proclamation, and do hereby offer a Reward of Fifty Pounds to whomsoever shall give such information to Her Majesty's Attorney General, of the person or persons by whom the above offence was committed, as may lead to the apprehension and conviction of the Offencer or Offenders.

Given under my Hand and Seal at Fredericton, on the twenty first day of May, in the year of our Lord one thousand eight hundred and forty five, and in the eighth year of Her Majesty's Reign.
