WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the month of March, 1846, pass fifty six Acts which have been transmitted, entitled as follows, viz :—

No. 1648. An Act to continue and amend the Act, intituled "An Act imposing Duties for raising a Revenue."

No. 1649. An Act for the collection of the Revenue of this Province.

No. 1651. An Act to remove doubts respecting the competency of Witnesses in certain cases.

No. 1652. An Act to amend and explain an Act, intituled "An Act to repeal all the Acts in force relating to Trespasses, and to make more effectual provision for the same."

No. 1654. An Act to alter the Division Line between the Counties of Westmorland and Albert, and also certain Parish Lines in the said County of Albert.

No. 1655. An Act to alter and amend the Laws relating to the Fisheries in the County of Gloucester.

No. 1656. An Act to authorize the Justices of the Peace for the County of Restigouche, to levy an assessment to pay off the County Debt.

No. 1657. An Act to authorize the Justices of the Peace for the County of Kent, to levy an assessment to defray the contingent expenses of the said County.

No. 1658. An Act to authorize Her Majesty's Justices of the Peace of the County of Gloucester, to assess the said County for payment of the County Debts.

No. 1659. An Act to authorize Her Majesty's Justices of the Peace for the County of Northumberland, to assess the said County to pay off the County Debts.

No. 1660. An Act to authorize Her Majesty's Justices of the Peace for the County of Charlotte, to levy an assessment to pay off the County Debt.

No. 1661. An Act relating to Dog Tax in the several Counties of this Province.

No. 1662. An Act to authorize the Justices of the Peace for the County of Carleton, to levy an assessment to pay off the County Debts.

No. 1663. An Act to make provision for winding up the affairs of the Savings' Bank at Fredericton.

No. 1664. An Act to provide for the management of the tem-

poralities of the Church of England in this Province, in certain cases.

No. 1665. An Act to repeal an Act, intituled "An Act in addition to an Act for erecting a Parish in the City of Saint John, and incorporating the Rector, Church Wardens and Vestries of the Church of England in the several Parishes in this Province," and to make other provisions in lieu thereof.

No. 1666. An Act to enable the Rector, Church Wardens and Vestry of Trinity Church, in Springfield, King's County, to dispose of certain Lands held by them, in exchange for other Lands.

No. 1667. An Act to authorize the Justices of the Peace for the County of Albert, to assess the said County for erecting a Court House and Gaol therein.

No. 1668. An Act to remedy certain difficulties in legal proceedings occasioned by the late division of the County of Westmorland, and for other purposes relating to the County of Albert.

No. 1669. An Act to establish Polling places in the County of Albert.

No. 1670. An Act relating to the Fencing, Occupation, and Grazing of the several Marshes, Low Lands and Meadows in the County of Albert.

No. 1671. An Act to facilitate the carrying into effect conditional Pardons granted by the Crown.

No. 1672. An Act relating to the crime of Manslaughter.

No. 1673. An Act in amendment of the Law relating to the appointment of Sheriffs.

No. 1674. An Act to amend the Law relating to Absconding Debtors.

No. 1675. An Act to provide for the safe keeping of the Public Records of the City and County of Saint John.

No. 1676. An Act relating to the Public Debt of the Corporation of the City of Saint John.

No. 1677. An Act relating to County and Parish Officers in the City and County of Saint John.

No. 1678. An Act to authorize the Justices of the Peace for the County of Saint John, to make further provision for the payment of the Treasurer of that County.

No. 1679. An Act to amend and explain "An Act to authorize the Justices of the Peace in the several Counties in this Province, to make Regulations for Markets."

No. 1680. An Act to authorize the extension of the Gaol Limits in the County of Sunbury.

No. 1681. An Act to empower the owners of certain Saw Mills on Hammond River, in King's County, to erect and keep up a Boom or Booms for the securing of Saw Logs on the said River.

No. 1682. An Act to alter the Great Road from Fredericton to Saint Andrews.

No. 1683. An Act to continue "An Act to prevent the spread of a disorder now existing in certain parts of the Counties of Gloucester and Northumberland."

No. 1684. An Act to continue "An Act to revive certain Acts relating to the prevention of the importation and spreading of Infectious Distempers within the Counties of Charlotte and Northumberland, and to extend the provisions of the same to the Counties of Gloucester and Restigouche."

No. 1685. An Act for erecting a part of the Parishes of Saint Mary's and Douglas, in the County of York, into a separate and distinct Town or Parish.

No. 1686. An Act to annex certain Islands in the River Saint John, to the Parish of Queensbury, in the County of York.

No. 1687. An Act to provide for the repair of the Streets and Highways in part of the Parish of Woodstock.

No. 1688. An Act to repeal the Laws now in force for appointing Firewards, and the better extinguishing of Fires, so far as the
