**W**HEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did, in the month of April, 1846, pass two Acts, which have been transmitted, entitled as follows, viz:—

No. 1641. An Act to increase the Representation of the County of Albert.

No. 1642. An Act to incorporate the Roman Catholic Bishop in New Brunswick.

And Whereas the said Acts have been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council appointed for the consideration of all matters relating to Trade and Foreign Plantations, and the said Committee have reported as their opinion to Her Majesty, that the said Acts should receive Her Majesty's special confirmation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to declare Her special confirmation of the said Acts, and the same are hereby specially confirmed, ratified, and finally enacted accordingly: Whereof the Governor, Lieutenant Governor or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

### CAP. LXXI.

An Act to increase the Representation of the County of Albert.

Passed 7th March 1846.

**W**HEREAS it is deemed necessary to increase the Representation of the County of Albert;

I. Be it enacted by the Lieutenant Governor, Legislative Council and Assembly, That the County of Albert shall be entitled to send one additional Member to serve in the General Assembly of this Province, to be elected by the Freeholders in the said County, in like manner and subject to the like laws, rules and regulations under which Members are elected in the several Counties within this Province.

II. And be it enacted, That this Act shall not be of any force or effect until Her Majesty's assent thereto shall have been duly signified.

[This Act was specially confirmed, ratified and finally enacted by an Order of Her Majesty in Council, dated the 6th day of July, 1846.]

### CAP. LXXII.

An Act to incorporate the Roman Catholic Bishop in New Brunswick.

Passed 11th April 1846.

**W**HEREAS it is deemed just and expedient to incorporate the Right Reverend William Dollard, Roman Catholic Bishop in the Province of
