ARMY CONTRACTS.

FRESH BEEF.

Such quantities of Ox or Heifer Beef of the best marketable quality, as may be required for Her Majesty's Land Forces at Fredericton and Woodstock, during the 12 months commencing the 1st January next. The deliveries to the Troops to be made from the Contractor's Shop or Stall, and to consist of HIND and FORE QUARTERS, and no other, subject to the inspection and approval of the Commissariat; and to be conveyed to the Barracks at the expense of the Contractor.
