An Act to authorize Her Majesty's Justices of the Peace of the County of Gloucester to assess the said County for payment of the County Debts.

Passed 7th March 1846.

Assessment authorized to pay the County Debts.

BE it enacted by the Lieutenant Governor, Legislative Council and Assembly, That Her Majesty's Justices of the Peace of the County of Gloucester, at any General or Special Sessions of the Peace hereafter to be holden, be and they are hereby authorized and empowered to make such rate and assessment of any
