Which Resolution having been put, also passed unanimously. The thanks of the Meeting were then voted to the Chairman and

THE FOLLOWING IS THE ADDRESS.

At twelve o'clock this day it was presented to His Excellency by a numerous body of the subscribers, and His Excellency was pleased to make the subjoined reply.

To His Excellency Major General Sir John Harvey, Knight Commander of the Most Honorable Military Order of the Bath, Knight Commander of the Royal Hanoverian Guelphic Order, Lieutenant Governor and Commander in Chief in and over Her Majesty's Province of Nova Scotia and its Dependencies, &c. &c. &c.

We the undersigned citizens of Halifax and others, Her Majesty's faithful subjects of Nova Scotia, offer to Your Excellency and Lady Harvey, our respectful congratulations and good wishes on your arrival in Halifax.

Your Excellency's name has long been honorably connected with the history of British North America. During war the able counsel and intrepid and skillful conduct of Your Excellency were crowned with results the most distinguished and important. While the successful administration of the affairs of three Colonies throughout a lengthened period is evidence of Your Excellency's zeal and ability in Civil Government.

Coming as Your Excellency does to our shores from a Colony which justly acknowledges the beneficent influences of Your Excellency's rule, we look forward with confident hope to your prosperity and success in the duty which Her Majesty's confidence in your past services, has assigned to you among ourselves.

To effect this result Your Excellency may rely on our best exertions, and we offer to Your Excellency as the truest pledge of our sincerity, the assurance of our respect for the high office you hold as Representative of the Sovereign, and of our personal esteemof devoted attachment to our Gracious Queen, and of our deep conviction that the welfare of the Colony and the happiness of the inhabitants, will ever be best promoted under the fostering protection of the Parent State, which under its happy constitution has reached the highest degree of prosperity and glory.

## REPLY.

My Lord Bishop and Gentlemen,

This expression of your kind congratulations on our arrival among you is most gratifying to Lady Harvey and myself. We had not indeed approached your shores with the feelings of strangers, but if we had, this Address and the reception which we have experienced would at once have converted them into those of friends.

As a Soldier I am proud and gratified for the language which you have thought fit to employ in adverting to my services in connection with the military operations in Canada during the last war. Any success which may through the Divine blessing have attended my administration of civil affairs I refer with equal pride and satisfaction to the admirable manner in which my endeavours to discharge the important duties confided to me by my gracious Sovereign have been every where sustained by those over whom I have had the good fortune to preside.

Permit me then to say to you, Gentlemen, that the assurance of your support now so frankly and so kindly tendered to me, leave me nothing to apprehend as to the the result of those endeavours which I on my part pledge myself zealously to devote to your service.

I do not conclude this our first brief communication, without adverting with great satisfaction to the declaration which your Address embodies, of that loyal devotion to the Sovereign, that firm attachment to British Connection, and that pride in our free and happy Institutions for which the inhabitants of the British North American Colonies have at all times been eminently distinguished, and which constitute a band of union between them and the Parent State, which as nothing can ever dissever, so will nothing I trust ever weaken or disturb.
