SIR,-It is with much regret I learn, that owing to many pressing matters consequent on the departure of Sir John Harvey for Halifax, Your Excellency's Letter of the 3d August, enclosing a Bill of £825 13 10 Sterling, for the relief of the sufferers by the fearful fire which destroyed this City, was not acknowledged by His Excellency.

I now beg to assure Your Excellency that the deepest gratitude has been felt by all classes of people here for the very noble donation made by your Government, and I trust that the want of an earlier declaration of it will, under the circumstances I have stated, be excused.

SIR,—I felt much pain in learning from your Letter of the 19th ultimo, and from Sir John Harvey, that no acknowledgment had been made of the sum of £825 13 10 Sterling, advanced from the Provincial Chest of your Government, in aid of the Sufferers by the late Fire in this City.

By the Packet which left Halifax on the 18th of August, and in which the Letter enclosing the Bill for this sum arrived, I returned after an absence of some duration, and found Sir John Harvey on the point of leaving this for the Government of Nova Scotia. The Bill was handed by Sir John to the Chairman of the Relief Committee, and not passing through my hands, and being pressed by much business, consequent on my own absence from the Colony, and Sir John Harvey's immediate departure, this unfortunate omission occurred, which, under the circumstances I have stated, I trust may be excused.

Colonel Law, the officer administering the Government, writes by this opportunity to His Excellency Sir William Colebrooke an

official acknowledgment of the Bill in question.
