I. It is further Ordered, That such of the Rules and Orders of this Court as are inconsistent with the said Rules and Regulations of the Barristers' Society, or so far as they regulate matters therein provided for, (excepting as aforesaid,) be suspended until the further order of the Court in the premises.
