## A PROCLAMATION.

HEREAS the General Assembly of this Province stands prorogued to the last Tuesday of this present month of September, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued to the last Tuesday in December.

Given under my Hand and Seal at Fredericton, the twenty first day of September, in the year of our Lord one thousand eight hundred and forty seven, and in the eleventh year of Her Majesty's Reign.

No. 1730. An Act relating to certain public Lands in Fredericton. No. 1731. An Act to provide for the establishment of a Grammar School in the County of Albert.

No. 1732. An Act to continue an Act, intituled An Act to repeal an Act, intituled An Act relating to the Market in Fredericton, and to make other provisions relating thereto.

No. 1737. An Act to establish the line of Road leading from Pickard's Store, in the Parish of Andover, in the County of Carleton, to the American Boundary, one of the Great Roads of Communication in the Province.

No. 1738. An Act in addition to an Act in amendment of an Act, intituled An Act to provide for the repair of the Streets and Highways in part of the Parish of Woodstock.

WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did, in the months of March and April, 1847, pass fifty six Acts, which have been transmitted, entitled as follows, viz:—

No. 1724. An Act to re-establish the Easter Term of Her Majesty's Supreme Court of Judicature in this Province.

No. 1725. An Act to authorize a special Term of the Court of Governor and Council for the determination of all suits and controversies touching and concerning Marriage and Divorce.

No. 1726. An Act to prevent the free Navigation of the Internal Waters of the Province from being impeded by any Railway works.

No. 1727. An Act to suspend the operation of the 6th and 7th Sections of an Act for the further regulation of Fisheries, and for preventing their decay in certain cases.

No. 1728. An Act to establish the provisions of an Act, intituled An Act for the appointment of Firewards in the Parish of Woodstock, to the Bend of the Petitcodiac, in the County of Westmorland.

No. 1729. An Act to extend the provisions of an Act, intituled An Act to repeal the Laws now in force for appointing Firewards and the better extinguishing of Fires, so far as the same relates to the Towns of Newcastle and Chatham, in the County of Northumberland, and to make regulations more suitable for the said Towns, and for other purposes therein mentioned, to the Town of Douglastown, in the said County, Peace of the County of York to levy an assessment to pay off the County Debt.

No. 1740. An Act to authorize Her Majesty's Justices of the Peace for the County of York to levy an assessment to pay off the debt due upon the new Gaol recently erected in the said County.
