SIR,-Her Majesty's Government have had under their consideration two Acts passed by the Legislature of New Brunswick, and intituled respectively "An Act to incorporate the New Brunswick Railway Company," and "An Act to facilitate the making of a Railway from the City of Saint John, through Fredericton and Woodstock, to the Grand Falls of the River Saint John, and from thence to the Boundary Line of the Province of Canada, by the New Brunswick Company."
