GOVERNMENT NOTICE.

THE particular attention of the Deputy Treasurers at the several Out Ports in the Province, acting as Government Emigration Agents, is called to the "Rules under which money may be remitted through Her Majesty's Colonial Land and Emigration Commissioners, for the assistance of Emigrants after their arrival in British North America," published in the Gazette of the 28th of April last, and a strict observance of the annexed Heads of Instructions is enjoined.

In case of the arrival of Emigrants before the remittance, the Deputy Treasurers are authorized to make the necessary advances on being fully assured of the facts, and they will forthwith report the circumstances for the information of His Excellency the Lieu-

tenant Governor.

Heads of Instructions to the Government Agents in Canada and New Brunswick, for relieving Emigrants on arrival, out of private funds deposited for the purpose with the Colonial Land and Emigration Commissioners in England.

1. With a view of affording facilities to Landlords and others who may be desirous of assisting Emigrants after their arrival in Canada and New Brunswick, Her Majesty's Government have canctioned the arrangements contained in the accompanying paper, which sufficiently explains the details of the Plan so far as regards all proceedings in England.

2. It will be observed that those persons who wish to avail themselves of the plan, must deposit with the Commissioners the money to be remitted to the Colony, making out in duplicate and in a prescribed form a list of the Emigrants to be assisted, and specifying the manner in which the assistance is to be afforded.

3. On the face of this list the Commissioners will certify that the money has been lodged with them, and they will cause to be forwarded one copy by the Ship in which the Emigrants sail, and the other by the next Mail Steamer, both addressed to the Government Emigration Agent at the Port of disembarkation. This list will also bear a certificate signed by the Government Emigration Agent or Officer of Customs at the Port of embarkation, shewing how many of the people originally placed on the list by the depositor, actually embark.

4. On receipt of either copy of the lists duly certified and signed as above explained, it will be the duty of the Government Emigration Agent at the Port of disembarkation, to pay over to the Emigrants the sums set opposite to their respective names, or to provide provisions and conveyance for them to their ultimate destination, in any case where such an appropriation is directed by the depositor.

Should any of the Emigrants desire not to receive until they reach their ultimate destination, the whole or any part of the money made payable to them on landing, the Agent will endeavour to make arrangements through the Local Banks to give effect to this wish.

In the absence of any specific directions from the depositor, the Agent will lay out the money for the benefit of the people in such manner as he may judge most to their immediate advantage.

7. To enable the Agent to make the necessary disbursments, the Melly, William Commissioners will by the Mail Steamer, which conveys the dupli- Morris, James

cate list, forward a remittance or credit through the Agency of the Bank of British North America, in London, which is understood to have Branches in the several North American Colonies. But should the remittance in any case not arrive as soon as the Emigrants, the Agent will nevertheless consider himself authorized to make the payments according to the list conveyed in the vessel in which the Emigrants sail, provided it be duly certified and signed as before explained, and if he has not at his disposal any funds out of which he can make a temporary advance, the Agent will forthwith apply to the local Government for the requisite amount, which he will refund immediately on the receipt of the credit sent out by the Commissioners.

8. The Agent will by the first Mail Steamer in each month, transmit to the Colonial Land and Emigration Commissioners, a statement exhibiting in sterling and currency, the sums he may have received, and will at the same time return one copy of each list of Emigrants which may have reached him from England, shewing thereon the number of persons assisted by him, and the mode in which the assistance has been afforded. He will also at the close of the Emigration season, transmit to the Commissioners a summary of all the money received by him for this service during the year, and state generally how it has been applied.

5. Should any Emigrant named in the list not have embarked or die after embarkation, the sum, if any, specifically appropriated for such person by the depositor, is to be applied by the Agent as he may think best for the benefit of any family such person may have on board. But if there be no near relative, such as a father, mother, child, brother or sister, the Agent will retain the money intended for the absent or deceased individual, until he shall have reported the circumstance to the Commissioners, which he will do without delay, and have received their instructions. He will in like manner retain the money in every case in which he may have good grounds for suspecting personation or any other fraud.

6. Whenever the Emigrants are to receive the assistance in money, it will be prudent that the Agent should pay it over to them in the presence of some third person, and should also take a receipt

from the Emigrants for his discharge.
