CAPTURE OF FOUR SLAVERS .-- By a French steamer arrived from St. Thomas's, we have accounts of the capture of four slave vessels-three of them by the Ferrett, S, Commander Sprigg. The first captured by the Ferrett, was taken June 27th, after a long chase by night. She was a Brazilian brigantine of 180 tons, fully equipped, and bound to Cape Lopez. The Ferrett, three weeks after that, captured a small schooner named the Sebastino, also fully equipped; and on the 16th of July, off Cape Maguerita, gave chase to a Brazilian brig, which turned out on capture to be the

Supposing the Boston and Halifax Steamers to sail on the Great Circle on the outward passage to Liverpool from position off Cape Race, the difference of distance between the New York and Southampton Steamers, and the Boston and Halifax and Liverpool Steamers is 307 miles, or equal to 8 1-10 more distance run by the New York and Southampton Steamers, than the Boston, Halifax and Liverpool Steamers.

The calculations are in nautical miles, 691 statute miles make a degree of 60 nautical miles .- To make a nautical mile add 15 5-6 to a statute mile.

MELANCHOLY ACCIDENTS .- We learn by a private letter from Richibucto, that on Thursday the 4th instant, two boys, sons of Mr. Long, Postmaster at Cocagne, in the County of Kent, were unfortunately drowned by the upsetting of a canoe while on a shooting expedition in that neighborhood.

On Sunday evening last, two colored men, one named Leek, the other Francis, were drowned opposite Sheffield, while endeavoring to secure a raft of timber which they had been engaged to carry to St. John. It appears the unfortunate men had thrown an anchor from a boat without taking care that the warp attached was properly coiled and cleared, and in running out the warp got foul of some part of the boat, which being laden, was immediately filled, and sunk by the weight and sudden jerk of the anchor. There were three individuals in the boat at the time, one of whom escaped by swimming for the raft, the other two unfortunately perished .-Head Quarters.
