contingent and annual expenses have been deducted, are insufficient to cover and pay the said annual profit or interest of five per centum on the capital sum, not exceeding one hundred thousand pounds, invested as aforesaid, and are deficient in a certain sum to be specified in the certificate of the persons to be appointed as aforesaid, it shall and may be lawful for His Excellency the Lieutenant Governor or Administrator of the Government for the time being, by and with the advice and consent aforesaid, to issue a Warrant under his hand and seal, on the Provincial Treasury, for the payment to the said Company of the sum so certified to be deficient; which Warrant the Treasurer of the Province is hereby required to pay in the regular course out of the monies then in the Treasury, or as payments may be made at the same : Provided always, that unforeseen casualties, by which temporary suspensions of the traffic of and travelling on the said part of the said contemplated Rail Road, not involving neglect on the part of the said Company, shall not be deemed sufficient to authorize the persons so appointed as aforesaid to withhold their certificate, and thereby prevent the payment of the sum necessary to make up such deficiency as aforesaid that may occur in the year in which the casualties may take place; it being the true intent and meaning of this Act, that the said Company shall realize and receive as a clear profit, arising from the net profits, or from the net profits and sum to be paid by the Province jointly, a rate of interest equal to five per centum on such capital sum not exceeding one hundred thousand pounds, as may be invested in the said part of the said contemplated Rail Road, and its said Branches, during each and every year, not exceeding ten years in the whole, that the said part of the said contemplated Rail Road shall be in efficient operation as aforesaid.

VII. And be it enacted, That this Act shall not come into operation or be in force until Her Majesty's Royal approbation be thereunto first had and declared. approbation be

Act suspended till Her Majesty's declared.

This Act was specially confirmed, ratified and finally enacted by an Order of Her Majesty in Council, dated the 20th day of May, 1847.]

## GOVERNMENT NOTICE.

THE particular attention of the Deputy Treasurers at the L several Out Ports in the Province, acting as Government Emigration Agents, is called to the "Rules under which money may be remitted through Her Majesty's Colonial Land and Emigration Commissioners, for the assistance of Emigrants after their arrival in British North America," published in the Gazette of the 28th of April last, and a strict observance of the annexed Heads of Instructions is enjoined.

Provincial Secretary's Office, 27th May, 1847.

Heads of Instructions to the Government Agents in Canada and New Brunswick, for relieving Emigrants on arrival, out of private funds deposited for the purpose with the Colonial Land and Emigration Commissioners in England.

1. With a view of affording facilities to Landlords and others who may be desirous of assisting Emigrants after their arrival in Canada and New Brunswick, Her Majesty's Government have sanctioned the arrangements contained in the accompanying paper, which sufficiently explains the details of the Plan so far as regards all proceedings in England.

2. It will be observed that those persons who wish to avail themselves of the plan, must deposit with the Commissioners the money to be remitted to the Colony, making out in duplicate and in a prescribed form a list of the Emigrants to be assisted, and specifying the manner in which the assistance is to be afforded.

3. On the face of this list the Commissioners will certify that the money has been lodged with them, and they will cause to be forwarded one copy by the Ship in which the Emigrants sail, and the other by the next Mail Steamer, both addressed to the Government Emigration Agent at the Port of disembarkation. This list will also bear a certificate signed by the Government Emigration Agent or Officer of Customs at the Port of embarkation, shewing how many of the people originally placed on the list by the depositor, actually embark.

4. On receipt of either copy of the lists duly certified and signed as above explained, it will be the duty of the Government Emigration Agent at the Port of disembarkation, to pay over to the Emigrants the sums set opposite to their respective names, or to provide provisions and conveyance for them to their ultimate destination, in any case where such an appropriation is directed by the depositor. Should any of the Emigrants desire not to receive until they reach their ultimate destination, the whole or any part of the money made payable to them on landing, the Agent will endeavour to make arrangements through the Local Banks to give effect to this wish.

In the absence of any specific directions from the depositor, the Agent will lay out the money for the benefit of the people in such manner as he may judge most to their immediate advantage.

7. To enable the Agent to make the necessary disbursments, the Commissioners will by the Mail Steamer, which conveys the duplicate list, forward a remittance or credit through the Agency of the Bank of British North America, in London, which is understood,
