By yesterday's mail we received a copy of a Bill introduced by Mr. Stewart, of Bytown, "to incorporate the Canada, New Brunswick and Nova Scotia Railway Company." It authorizes the Honorable John Molson, the Honorable Adam Ferrie, the Honorable James Ferrier, the Honorable John Neilson, the Honorable R. U. Harwood, Sir George Simpson, P. W. Dease, Allan M'Donell, Robert Armour, Charles H. Castle, John Try, Henry Corse, John Matthewson, W. B. Jarvis, Joseph Cary, and Josiah Timmis, Junior, Esquires, with such other persons as shall become shareholders of the Company, "to make and complete a Railway, to be ealled The Canada, New Brunswick and Nova Scotia Railway, with one or more sets of rails or tracks, and to be worked by locomotive engines, or on the atmospheric principle, or in such other mode as the said Company may deem expedient, from some place on the River Saint Lawrence as nearly opposite the City of Montreal as may be found convenient, through the Eastern Townships, by Melbourne or Drummondville, to Point Levy, ney, Sturdee & Co. opposite to Quebec, and thence by Rivière-du-Loup to the Province line of New Brunswick;" and enacts that "wherever the said Railway shall pass through the waste or ungranted lands of Her Majesty, there shall be granted to the said company such wild lands, for the space of five miles wide, on each side of the said Railway, together with the timber thereon, and the mines, materials and minerals in the same, but not exceeding in the whole two millions of acres, for and towards the construction of the said Railway, and the more convenient and speedy settlement of the said wild lands, and for the purpose of enabling the said company to meet the great expense of the said undertaking, and as an aid towards the same."-Quebec Gazette.
