VI. ## CAP. LXXI.

An Act to provide for the incorporation of certain Presbyterian Churches in this Province not in connexion with the Established Church of Scotland.

Passed 14th April 1847.

6 TATHEREAS it appears to be the desire of the members of the Presby- Preamble. ' terian Church in the City of Saint John, and of other Churches 'established in the said Province, having relation with Presbyterian bodies in Great Britain and Ireland, but not being in connexion with the Established Church of Scotland, to be incorporated, to enable them to manage the temporal affairs of the said Churches, and to provide for certain matters in reference to

' the call and qualification of the Ministers and otherwise;'

I. Be it therefore enacted by the Lieutenant Governor, Legislative Council Persons herein and Assembly, That the following persons, namely, Andrew Reed, James Dunn, successors, Trustees Thomas Parks, John Hawks, and William E. Moore, together with the Elders of the said Church, namely, William Parks, Robert Ritchey, Robert Keady, and Church in the City George Hutchinson, be and they are hereby declared to be Trustees for the said Church until the election and appointment of not more than nine other Trustees Church in New as hereinafter directed, and that the above named Trustees and their successors, not in connexion (the said nine Trustees and their successors to be chosen and appointed in with the Estamanner hereinafter mentioned,) for ever shall be a body politic and corporate in Scotland, incorpodeed and name, and shall have succession for ever by the name of The Trustees powers. of the Saint John Presbyterian Church in the City of Saint John, in connexion with the Presbyterian Church in New Brunswick, and not in connexion with the Established Church of Scotland; and by that name shall be enabled to sue and be sued, implead and be impleaded, answer and be answered unto, in all Courts and places whatsoever, within this Province, and shall have full power and capacity to purchase, receive, take, hold and enjoy for the use and benefit of the said Church, as well goods and chattels, as lands, tenements and hereditaments, and improve and use the same for the benefit of the said Church, according to their best discretion, and the true intent and meaning of the donors when the same shall be given, devised or bequeathed to the use and benefit of the said Church: Provided always, that the amount of annual rents, profits and receipts of such lands, tenements, goods, chattels and hereditaments, shall not exceed the sum of five hundred pounds, any law, custom or usage to the contrary notwithstanding.

II. And be it enacted, That the lot of Land on which the said Church is built, Lot of Land on situate at the corner of Great George and Carmarthen Streets, in King's Ward, which the Church in the said City of Saint John, together with the lot adjoining, fronting on Great the Corporation. George Street, which lots of Land are at present vested in Trustees for the said Church, shall according to their full metes and boundaries, together with the said Church thereon erected, be and remain fully and absolutely vested in the said Trustees of the Saint John Presbyterian Church, in the City of Saint John, and their successors for ever, as a good and absolute estate in fee simple, for the use, trust and benefit aforesaid, and shall be so deemed and taken in all Courts of Law and Equity in this Province, any law, usage or custom to the contrary in any wise notwithstanding, saving to all purchasers of Pews in the said Church their present legal right therein and thereto, and saving the legal or equitable

right of all other persons.

III. And be it enacted, That on the first Wednesday in June in each year for an annual meeting ever hereafter, a meeting of the persons then being proprietors of Pews or male male communicants. communicants, shall be holden in the said Church; at which meeting, between the to be held on first
