TO ALL TO WHOM THESE PRESENTS SHALL COME OR MAY CONCERN :

**K**NOW YE, that under and by virtue of the power and authority in me vested in and by an Act of Parliament made and passed in the fifth and sixth years of the Reign of Her Majesty Queen Victoria, intituled "An Act for regulating the Carriage of Passengers in Merchant Vessels," I do hereby declare by Proclamation, that the said Act, and every part thereof, except as therein excepted, shall apply and is hereby extended and applied to the carriage of Passengers by Sea from this Province of New Brunswick to any Port or Ports, place or places within the United Kingdom of Great Britain and Ireland.

### A PROCLAMATION.

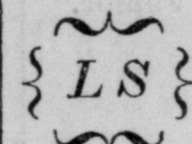
**W**HEREAS it appears by an Inquest held before Peter C. Amiraux and Vital Thibideau, Esquires, two of Her Majesty's Justices of the Peace for the County of Carleton, on view of the

body of Douglas Balloch, deceased, that the said Douglas Balloch came to his death by the discharge of a Gun, loaded with Gunpowder, a Leaden Bullet, some Buck-shot and Duck-shot, on the night of the eleventh of October last, fired off by some person or persons unknown; I do therefore publish this Proclamation, and do hereby offer a Reward of One Hundred Pounds to whomsoever shall give such information to Her Majesty's Attorney General, of the person or persons by whom the offence was committed, as will enable him to prosecute the Offender or Offenders to conviction.

### A PROCLAMATION.

**W**HEREAS it appears from information which I have received from the Justices of the City and County of Saint John, that on or about the hour of Seven o'clock in the Evening of Saturday last, the 4th instant, a murderous assault, by Stabbing, was committed in the Streets of Portland, in the said County, by one THOMAS BOWES, together with some other person or persons as yet unknown, upon James Goff, James Earle, and Henry Kinney, WATCHMEN, then being in the Execution of their duty; And whereas the said James Goff has since died from the effects of the wounds and violence inflicted on that occasion:—I do therefore publish this my Proclamation, and do hereby offer a Reward of TWO HUNDRED and FIFTY POUNDS, or One Thousand Dollars, to be paid to any person or persons (excepting the actual perpetrators of the fatal crime,) who shall apprehend the said THOMAS BOWES: And a Reward of ONE HUNDRED POUNDS, or Four Hundred Dollars, for such information to Her Majesty's Attorney General, as shall enable him to prosecute any of the offenders to conviction.

### DESCRIPTION OF THOMAS BOWES.

Slender figure, height about five feet seven, light complexion, blue eyes, a scar below the right eye, chin sharp, nose long and straight, hair light and rather long, whiskers thin, but the hair under the chin projecting to a point, and of a light sandy colour; age about twenty two years. When last seen at Saint John, had on a blue reefing jacket and light fustian trowsers.
