

hereby imposed by the person refusing or neglecting to remove the same.

V. And be it enacted, That no slop, wash, foul or dirty water of any description, shall be thrown or allowed to fall, flow or ooze into, over or upon any of the sidewalks, gutters, streets, sewers or other gratings thereof in the said City, under a penalty not exceeding twenty shillings nor less than five shillings for each and every offence; to be paid by the party offending, or by the occupier or occupiers respectively, (if more than one) of the house, shop or premises from which the same may have been allowed to fall, flow or ooze as aforesaid.

VI. And be it enacted, That no person or persons shall put or cause to be put in or upon any of the streets, lanes, alleys, highways, public squares or open plots of ground, within the said City, any timber or lumber of any kind whatsoever, or any stone, brick, lime, mortar or other materials for building, or any earth, rubbish or other incumbrance or obstruction whatsoever, without first having obtained permission in writing from the Mayor or City Council of the said City; and such permission shall only be granted to such person or persons as are or shall be erecting or repairing any house, store or other building; and no authority shall be given to any person or persons to occupy or incumber more than one fourth of the width of any such street, lane or alley, and not to extend beyond the breadth of the lot on which such house, store or other building is in course of erection or repair as aforesaid; and the person or persons obtaining such permission, shall, at his or their own expense, cause such building materials as aforesaid to be enclosed with a sufficient fence, and shall keep the same enclosed; and also, while such encumbrance shall remain, shall cause a lamp to be placed on some conspicuous part of such encumbrance, if required so to do by the proper officer or officers for that purpose appointed, and shall keep the same constantly lighted during the night, so as to prevent any danger or inconvenience to the public, under a penalty of twenty shillings for each and every offence.

VII. And be it enacted, That no lime shall hereafter be slacked or riddled on any of the public streets, highways, lanes, squares, open plots of ground, wharves or landing places within the said City, for any purpose or purposes whatsoever, under a penalty of twenty shillings for each and every offence.

VIII. And be it enacted, That any person or persons may be permitted to plant or set out trees along the sides of any of the streets of the said City provided that such person or persons do not unnecessarily encroach upon the sidewalks or gutters thereof, and that every person or persons who shall maliciously injure or remove the said trees so planted out, or any trees which have heretofore been planted, or may hereafter be planted on any street, square, highway or open plots of ground, or along the River bank, shall for each and every offence forfeit and pay a penalty of five pounds.

IX. And be it enacted, That it shall be the duty of every person or persons occupying or possessing premises within that part of the said City comprised within the town plot, on Saturday in each and every week, from the first day of May until the first day of October in each and every year, or oftener as may be directed by the proper officer or officers for that purpose appointed, to sweep up the dust, dirt or rubbish in front of their respective tenements, and to clear up the rubbish accumulating in the gutters; and in case the weather should prove unfavourable on such Saturday, then such cleaning shall be done on the first day thereafter, (not being Sunday); and for every neglect, the party neglecting or offending shall forfeit and pay a penalty of five shillings.

X. And be it enacted, That no papers, shavings, dirt or rubbish of any kind whatsoever, shall be thrown,

cast or swept from any house, warehouse, store, shop, stoop, platform or erection of any description, or from any yard, lot or piece of land, in or upon any of the public streets, wharves, squares or open plots of ground within the said City, or any part thereof, under a penalty not exceeding twenty shillings nor less than five shillings for each and every offence; to be paid by the person or persons so offending, or by the occupier or occupiers respectively, (if more than one), of the house, warehouse, store, shop, stoop, platform or other erection, yard, lot or piece of land from which the same may be thrown, cast or swept as aforesaid.

XI. And be it enacted, That any person who in any thoroughfare, shall beat or shake any carpet, rug or mat, (except door mats before the hour of eight in the morning) or throw or lay any dirt, litter or ashes, or any carrion, fish, offal or rubbish, or throw or cause any such thing to fall into any sewer, pipe or drain, or into any walk, stream or watercourse, pond or reservoir for water, or cause or permit any offensive matter to ooze from any manufactory, brewery, slaughter house, butcher's shop, privy or dung-hill, into any thoroughfare, shall for each and every offence forfeit and pay a penalty not exceeding five pounds nor less than five shillings; provided always nevertheless, that it shall not be considered an offence against the provisions of this section, for any person or persons to lay sand, ashes or other materials in any thoroughfare in time of frost, to prevent accidents, or litter or other materials to prevent the freezing of water in pipes, or frost in cellars, or in cases of sickness, to prevent noise, if the party laying any such sand, ashes or other material, shall cause the same to be removed so soon as the occasion therefor shall cease.

XII. And be it enacted, That no person or persons shall clean out, remove or convey, or caused to be cleaned out, removed or conveyed along the streets of the said City, between the first day of May and the first day of November in each and every year, any night soil or dirt from any privy or other building within the said City, under a penalty of five pounds for each and every offence; and such night soil or filth shall only be removed between the said first day of November and the first day of May, between the hours of nine o'clock in the evening and five in the morning, under a penalty not exceeding five pounds nor less than five shillings for each and every offence.

XIII. And be it enacted, That no person or persons whosoever shall saw or cut any wood on any of the sidewalks in the said City, under a penalty of five shillings for each and every offence, and a further penalty of five shillings for each and every hour he or they shall continue sawing after having been warned to desist by the Surveyor of Highways, Streets and Bridges, or any Constable of the said City.

XIV. And be it enacted, That no cartman, drayman or other person, shall unload, put or place any firewood, coals or other incumbrance on the foot path or sidewalk of any street within the said City, under a penalty of ten shillings for each and every offence; and all wood which may be placed or unladen on any other part of any street within the said City shall immediately on the unloading thereof, be piled up within two feet from the curbing, towards the middle of the street, and in one tier along the length thereof, (such pile not to contain more than one cord) under a penalty of two shillings and six pence for each and every offence, to be paid by the person or persons for whom the said wood may be hauled or piled; and no wood so hauled and piled as aforesaid, shall be suffered to remain on the said street after eight o'clock in the evening of the day on which it shall have been so hauled and piled as aforesaid; and if any firewood be suffered to remain upon any street for a longer period than six hours after notice shall be given to remove the same by the Surveyor of Highways, Streets and Bridges, or any Constable of the said City,
