roads, shall immediately on meeting or being overtaken by such person or persons aforesaid, keep his or her carriage or other vehicle as aforesaid, or his or her horse, on the left or near side of the street or road, thereby giving to such person or persons one half the said street or road; or if any person or persons shall in any manner negligently or wilfully hinder or prevent any other person or persons from passing him or her, or any carriage or other vehicle as aforesaid, under his or her care, upon such street or road, or by negligence or misbehaviour prevent, hinder or interrupt the free passage of any carriage or other vehicle as aforesaid, on any such street or road, or shall suffer his or her horse or horses, or other beast of draught, to proceed on such road or street without having some person to direct and govern such horse or horses or other beasts of draught, or shall be at such a distance from such carriage or other vehicle as aforesaid, or in such a situation that he or she cannot have the direction or government of such horse or horses, or other cattle drawing the same, or if any person or persons whosoever driving any cart, waggon, sled or other vehicle of any description having any matter or things thereon, shall place and secure such matter or thing so that the same shall project beyond such cart or other vehicle as aforesaid, in such a manner as to obstruct or impede the passage of any person, horse, beast, carriage or other vehicle as aforesaid, every such person or persons so offending against any one of the provisions of this section, shall be liable to a penalty not exceeding five pounds; provided always, that nothing herein contained shall extend or be construed to extend to compel the owner or driver of any such sled or carriage, being laden, to turn out or give one half of the road or street to any light or unloaded sled, sleigh or carriage during the winter months, so always that the driver or owner of such laden sled or carriage shall, upon request made for that purpose, stop in some convenient place to let such light or unloaded sled, sleigh or carriage, or other vehicle, pass by during the winter months.

XXVI. And be it enacted, That no person or persons shall drive any sleigh or sled within the said City, without having three bells affixed to each horse, sleigh or sled, under the penalty of ten shillings for each and

every offence.

XXVII. And be it enacted, That every person or persons who shall at any time between the fifteenth day of March and the fifteenth day of December in each and every year, draw or haul any house or building whatsoever on any street, road, lane, or thoroughfare within the said City, shall for each and every offence forfeit and pay a sum not less than one pound nor exceeding five pounds; and every person or persons who within the said period of time shall drag or haul on any of the said streets, roads, lanes or thoroughfares aforesaid, any logs, boards, timber, scantling or any chattel or thing, without securing the same from touching the said said streets, roads, lanes or thoroughfares, shall for each and every offence forfeit and pay a sum of not less than ten shillings nor exceeding five pounds.

XXVIII. And be it enacted, That no person or persons shall dig any hole or holes, or dig or haul any sod, sand or earth from any street, highway, lane, landing, wharf, square, open plot of ground, or the River bank in the said City, or sink any post, or fasten or drag any anchor thereon, without a Licence from the Mayor or City Council, under a penalty not exceeding five pounds nor less than ten shillings for each and

every offence.

XXIX. And be it enacted, That no Chemist, Druggist, or vender of Drugs or poisonous materials within the limits of the said City, shall sell or deliver, or permit to be sold or delivered to any person or persons whomsoever, any laudanum, arsenic, or any of the more poisonous drugs or chemicals, in quantities sufficient to poison or destroy the health of any person, without a written order, signed by a legally qualified Surgeon or

Physician, or by a Justice of the Peace for the County of York; and that the name and quantity of each an every such poisonous drug or thing, when sold or delivered as aforesaid, shall be legibly marked and inscribed with the name and quantity thereof, and shall have marked thereon in large letters, the word Poison; and all persons offending against the provisions of this section shall forfeit and pay the sum of five pounds for each and every offence.

XXX. And be it enacted, That no person or persons shall go in to bathe between the hours of five in the morning and nine in the evening, from any part of the southwesterly bank of the River Saint John, between the upper boundary of the Government House grounds and Yerxa's Mill, under a penalty not exceeding twenty shillings nor less than five shillings for each and every

offence.

XXXI. And be it enacted, That no tannery, black-smith's shop, furnace or stationary steam engine, shall hereafter be established without Licence from the City Council, within that part of the said City comprehended within the following limits, viz: In front by the River Saint John; northwesterly by Smyth Street; in the rear by the rear line of Charlotte Street, and the prolongation thereof in an easterly direction, until it strikes the bank of the River aforesaid; and every person or persons offending against the provisions of this section shall be liable to a penalty of five pounds for each and every offence, and twenty shillings in addition thereto for every day the same shall be continued.

XXXII. And be it enacted, That every owner on occupier of any store, shop or tenement upon the ground flat or floor of any tenement abutting on any of the planked sidewalks, shall on the Wednesday and Saturday of each and every week (except in rainy weather) from the first day of May to the first day of November in each year, sweep and water, or cause to be swept and watered, before ten in the morning, that part of the planked sidewalk lying in front of such store, shop or tenement, under the penalty of five shillings for each and every offence; and every owner, occupier or lessee of any store, shop, lands or premises abutting on any planked sidewalks, shall after every fall of snow, cause the said planked sidewalk to be cleaned in front of the said store, shop, lands or premises as aforesaid, by shovelling the snow and ice clear of the said planking, within three hours after it shall cease snowing, if it shall cease before two in the afternoon, and if not, then before the hour of eleven in the morning the next day, under a penalty of five shillings for each and every neglect; and that where any alley way intersects the said planked sidewalk, the owner or occupier of the lands or tenements abutting on the said planking on each side of the said alley way, shall keep half the said planking so intersected by the said alley way next to his or their respective lands or premises free from snow and ice as aforesaid, under the penalty aforesaid.

XXXIII. And be it enacted, That any person or persons who shall from any mill, building, steamboat, vessel or vehicle of any description, throw or cause to be thrown into the River Saint John, or haul or discharge upon the ice in the winter season, any slabs, edgings, sawdust, ashes, cinders, rubbish, tan bark, or other offensive matter or thing which may tend to injure the public health, or obstruct the navigation of the River Saint John, shall for each and every offence forfeit and pay a sum not exceeding five pounds nor less than twenty shillings.

XXXIV. And be it enacted, That no person or persons shall keep or open any public shows, theatrical exhibitions, or exhibitions of whatever name or nature to which admission is obtained on payment of money, without a Licence being first had and obtained from the Mayor or City Council of the said City, under a penalty not exceeding five pounds for each and every offence;
