CAP. LXIV.

An Act relating to Immigration, and the care and safe keeping of the Children and Property of deceased Emigrants.

6 THEREAS in consequence of the great influx of diseased and pauper Preamble. 'Emigrants into this Province, not only have heavy burthens been brought ' on the community, but the Emigrants themselves and their families have under-'gone much distress for want of any adequate provision being made for their 'necessities; for further remedy whereof,'

I.
