### REGISTRATION OF DEEDS.

**W**HEREAS Volumes No. 1 to No. 8 inclusive, of the Registry of Deeds for the Central District of Newfoundland, embracing a period extending from January, 1826, to June, 1844, were destroyed by fire on the 9th day of June, 1846, all parties holding Deeds, Wills, or other Assurances, which were Registered in any of the said Volumes, are hereby required, in compliance with an Act of the Legislature of this Colony, passed during the last Session of the General Assembly, to cause such Deeds, Wills, or other Assurances, or a Memorial thereof, to be again Registered in the Office of the Registrar of Deeds for the said Central District.

**N**OTICE is hereby given, that the Model and Training School, to be established under the Parish School Act, 10th Victoria, chap. 56, will be opened in Fredericton on Monday the 21st instant, for the reception of Pupils.—Applications for admission are to be addressed to the Teacher, Mr. Marshall d'Avray, or to Mr. J. Gregory, Secretary of the Board of Education, from either of whom the necessary information may be obtained as to the number of Pupils, the terms of admission, &c.

Preparations will be made in the School, without delay, for the Training of Parish School Teachers; and their attendance for the purpose of Instruction in the Method of Teaching, will commence from the 1st of March next.

The Secretary will communicate with those who have declared their readiness to repair to Fredericton, or who desire to do so, in order that as large a number may attend in rotation as can be accommodated.

The Teachers to be appointed to the charge of Training Schools in the Counties, will be selected from the Candidates who may attend for Training previous to the 1st of October next, and who may prove to be most competent.
