A PROCLAMATION.

HEREAS the General Assembly of this Province stands prorogued to the last Tuesday of this present month of June, I have thought fit further to prorogue the said General Assembly, and the same is hereby further prorogued to the second Tuesday in September next.

Given under my Hand and Seal, at Fredericton, the twenty first day of June, in the year of our Lord one thousand eight hundred and forty nine, and in the thirteenth year of Her Majesty's Reign.

SECRETARY'S OFFICE, Fredericton, 2d August, 1849.

SIR,—The Lieutenant Governor and Council, in selecting you to fill the office of Police Magistrate for the City of Saint John, have done so with full confidence of your personal fitness for the office.

Your duties will be sufficiently clear from the Act itself, the provisions of which are intended to exclude the Police Magistrate from mixing in any way with party politics. The Lieutenant Governor is desirous, particularly at this moment, of directing your attention to the importance of carrying out the spirit of these provisions of the Act in all appointments of your subordinate officers. The selection of your own Clerk and of the Police Constables is properly confided to you who are responsible for their efficiency and discipline.

The Clerk should accept his situation, subject to the condition that he is not to practise professionally in Magistrates' cases of any kind; and it is most important that no men should be appointed Constables whose habits of sobriety can be questioned, or whose previous position has been such, as to involve them in parties or factions. It is essential that they should discharge their duties fearlessly and impartially, as you yourself would desire to do; and that the public of all parties and opinions should feel perfect confidence in the protection afforded under the Law by their agency. Too great care cannot therefore be exercised in the choice of the men and in their instructions by yourself.

The Lieutenant Governor is desirous that that force should be organized as speedily as may be consistent with the principles and precautions set forth in this Letter.

No. 1882. An Act to facilitate the sale and improvement of Crown Lands in certain cases.

And whereas the said Act has been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council, appointed for the consideration of all matters relating to Trade and Foreign Plantations; and the said Committee have reported as their opinion to Her Majesty, that the said Act should be left to its operation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said Report: Whereof the Governor, Lieutenant Governor or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

No. 1876. An Act for the adjustment of claims of certain purchasers of Crown Lands.

No. 1877. An Act further to facilitate the making of a Rail Road from Saint Andrews to Woodstock, with a Branch to Saint Stephen.

No. 1879. An Act to incorporate the Saint John and Shediac Railway Company.

And whereas the said Acts have been referred to the Committee of the Lords of Her Majesty's Most Honorable Privy Council appointed for the consideration of all matters relating to Trade and Foreign Plantations; and the said Committee have reported as their opinion to Her Majesty, that the said Acts should receive Her Majesty's special confirmation; Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to declare Her special confirmation of the said Acts, and the same are hereby specially confirmed, ratified, and finally enacted accordingly: Whereof the Governor, Lieutenant Governor or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
