A LAW

To continue a Law, entitled "A Law to prevent the profanation of the Lord's Day, (commonly called Sunday,) in the City of Fredericton."

BE it enacted by the City Council of the City of Fredericton, That a Law to prevent the profanation of the Lord's Day, (commonly called Sunday,) in the City of Fredericton, be and the same is hereby revived and continued, and declared to be in full force and effect until the twentieth day of June which will be in the year of our Lord one thousand eight hundred and fifty: Provided always nevertheless, that nothing in the said recited Act contained, shall extend or be construed to extend to authorize the imprisonment of any offender against any of the provisions of the said Act for any time exceeding thirty days.
