SETTLERS' CROWN DEBTS.

REGULATIONS for carrying into effect the provisions of the Act 12 Victoria, cap. 19, intituled an Act to authorize the commutation of Debts due the Crown by Settlers in certain cases for work on the Public Roads."

1. That every Settler who may be entitled to avail himself of the privileges of the above Act, shall on or before the 15th day of June in each year, signify his desire so to do, to the Commissioner of the Parish or District in which his Lot may be situate, and shall at the same time deposit with the Commissioner the sum of one shilling on every pound of the debt for which he may be desirous of performing labour.

2. That when any Settler is indebted in a greater sum than $\pounds l_2$, he may reduce the same to that amount by payment of the difference to the Receiver General or to the Local Deputy of the County where the Land lies.

3. That where the debt due does not exceed $\pounds 5$, the whole amount thereof shall be discharged by labour in one season; and where the debt exceeds $\pounds 5$, two years may be allowed, if the applicant require it, for performing the labour therefor.

4. That each Commissioner do forward to the Provincial Secretary on or before the 1st day of May in each year, a list of the Public Roads in his District which it will be most desirable to open or improve, and which will be most convenient for the Settlers.

5. That every Commissioner shall strictly adhere to the requirements of the above Act and to these Regulations, and shall on or before the 1st day of November in each year, transmit to the Provincial Secretary the Returns required by Sections 7 and 8 of the above Act.

TIMBER CROWN BONDS.

All persons indebted by Bond to the Crown for Timber cut upon Crown Lands either under the five years Leases or in excess of Licence, or without Licence, and who have any just and equitable claims upon the Government for the reduction of the amounts of the said Bonds, are hereby notified, that such claims must be preferred by Petition to His Excellency the Lieutenant Governor on or before the 1st day of February next, setting forth specifically the grounds whereon such claims are founded, in order that the same may be duly investigated and dealt with according to the provisions of the Act 12 Vic., cap. 36; and in all cases where application shall not be made as aforesaid, immediate proceedings will be taken to enforce the payment of the said Bonds.

CLAIMS OF PURCHASERS OF CROWN LANDS.

All persons interested in the purchase of Tracts of Crown Lands exceeding 500 acres each, which were sold between the years 1832 and 1838, and for which the balance of purchase money has not been paid, and who are desirous of obtaining relief under the provisions of the Act 12 Vic., cap. 73, intituled "An Act for the adjustment of claims of certain purchasers of Crown Lands," are hereby notified that all such claims must be preferred by Petition to His Excellency the Lieutenant Governor on or before the 1st day of May next, and that such Petitions shall specifically set forth the state of purchase—the quantity of Land purchased—the price per acre-the amount actually paid, and at what time-whether any Timber or Logs, and what quantity has been cut or sold off the Land by the purchaser or his assigns; such statements to be duly verified and accompanied by the necessary proofs and vouchers, in order that due enquiry may be made into all such claims, and relief be afforded, agreeably to the provisions of the aforesaid Act of Assembly. No. 1897. An Act to alter and amend an Act, intituled "An Act to provide for the collection of County and Parish Rates."

No. 1898. An Act to authorize the Justices of the Peace for the County of Restigouche to levy an assessment on the inhabitants of the said County to pay off the County Debt.

No. 1899. An Act to authorize Her Majesty's Justices of the Peace for the County of Charlotte to assess the inhabitants of said County to pay off the County Debt, and to provide for the contingent expenses thereof.

No. 1900. An Act to authorize an assessment upon the Parish of Portland, in the City and County of Saint John, for lighting a part of the said Parish with Gas.

No. 1901. An Act to authorize Her Majesty's Justices of the Peace for the County of York to levy an assessment to pay off the County Debt.

No. 1903. An Act to authorize the commutation of Debts due to the Crown by Settlers in certain cases for work on the Public Roads.

No. 1904. An Act further to continue an Act to provide for the prompt payment of all demands upon the Provincial Treasury.

No. 1905. An Act to continue the Act to provide for the payment of Interest on Warrants.

No. 1906. An Act to alter and amend an Act, intituled "An Act relating to the Clerk of the Pleas."

WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did, in the months of April 1847, March 1848, and March and April 1849, pass sixty four Acts, which have been transmitted, entitled as follows, viz :--

No. 1797. An Act to incorporate the British North American Electro-Magnetic Telegraph Company.

No. 1866. An Act to incorporate the New Brunswick Electric Telegraph Company.

No. 1885. An Act in addition to and in amendment of an Act, intituled, "An Act for the more effectual prevention of Fires in the City of Saint John."

No. 1907. An Act to repeal an Act, intituled "An Act further to facilitate the means of supplying the City of Saint John with Water, and for the more effectual prevention and extinguishment of Fires within the said City."

No. 1908. An Act to authorize the Trustees of Saint Luke's Church, in Bathurst, to dispose of certain Lands.

No. 1910. An Act in addition to and in amendment of the several Acts now in force to provide for sick and disabled Seamen, not being Paupers, belonging to this Province, so far as the same relate to the County of Kent.

No. 1911. An Act to provide for the more effectually repairing the Roads and Bridges in the Parish of Campo Bello and Grand Manan.

No. 1912. An Act to provide for the management of the Provincial Lunatic Asylum.

No. 1913. An Act to consolidate and amend the several Acts of Assembly relating to the Criminal Law of this Province, so far as relates to the definition of certain indictable offences, and the punishment thereof.

No. 1914. An Act to consolidate and improve the Laws relative to the administration of Criminal Justice.

No. 1915. An Act to facilitate the performance of the duties of Justices of the Peace out of Sessions within this Province, with respect to Summary Convictions and Orders.

No. 1916. An Act to appropriate a part of the Public Revenue for the payment of the Ordinary Services of the Province.

No. 1917. An Act to appropriate a part of the Public Revenue for the Services therein mentioned.

No. 1918. An Act to provide for opening and repairing Roads and erecting Bridges throughout the Province.

No. 1919. An Act for the encouragement of Agriculture.

No. 1920. An Act for the adjustment of certain outstanding Bonds to the Grown.

No. 1921. An Act to provide for the improvement of the Navigation of the River Saint John.

No. 1922. An Act for the re-appropriation of the sums granted to the Counties of Northumberland and Restigouche at the last Session of the Legislature for the purchase of Seed.

No. 1923. An Act to consolidate and amend various Acts of Assembly relating to the further amendment of the Law.
