II. And be it enacted, That all the before mentioned sums of money shall be Money to be paid paid by the Treasurer of this Province, by Warrant of His Excellency the Lieutenant Governor or Administrator of the Government for the time being, by and with the advice of Her Majesty's Executive Council, out of the monies in the Treasury, or as payment may be made at the same.

An Act to appropriate a part of the Public Revenue for the services therein mentioned. Passed 14th April 1849.
