RESOLVED, That there be established in King's College a Scholarship, of the value of Fifteen Pounds per annum, for each County in the Province, to be held by some Pupil of the Grammar School in each County, except in the County of Westmorland; and in the County of Westmorland, the Scholarship for that County to be held by one of the Pupils of the Wesleyan Academy, at Sackville: That the Candidates for such Scholarships shall be examined by the Trustees and Masters of the respective Grammar Schools aforementioned, and in the County of Westmorland by the Principal and Teachers of the Academy; and a Certificate of the name of the successful Candidate, signed by the majority of the Examiners, shall be transmitted to the Registrar; and that such successful Candidate shall be entitled to the benefit of the Scholarship as soon as he shall be matriculated at the College, after the usual examination for Matriculation, and shall hold such Scholarship until the period when, in due course, he would be entitled to the Degree of B. A.
