

At a meeting of the City Council of the City of Fredericton, holden on the 28th day of April, A. D. 1849, the following Bye Law was read and enacted :—

A LAW

In addition to the Law to prevent Nuisances, and to protect the Public Health within the City of Fredericton.

I. **B**E it enacted by the City Council of the City of Fredericton, That from and after the publication of this Law, no Cows or Neat Cattle shall be permitted to run or go at large in any of the Streets, Lanes, Alleys, Highways, or Public Squares in any part of the said City, comprised within the following limits, that is to say : Commencing at the intersection of the Hanwell or Great Road leading to Saint Andrews with the Great Road to Canada ; thence in a southerly direction until it strikes the intersection of the continuation of Smyth Street with the rear line of the third range of Pasture Lots ; thence along said range until it strikes the continuation of Sunbury Street ; thence along said Street towards the River Saint John, until it strikes a new Street lately opened by the Honorable George Shore ; thence along said Street to the River ; thence up Stream to the upper boundary of the City ; and thence in a southerly direction to the place of beginning.

II. And be it enacted, That the owner or owners, or person or persons having the care of any Cows or Neat Cattle which may be found going at large within the limits aforesaid, contrary to the provisions of this Law, shall, for each and every Cow or other Neat Cattle so found going at large, forfeit and pay a penalty of five shillings, for the use of the City, to be sued for, recovered and levied in the manner prescribed by any Law of the Corporation now or which may hereafter be in force for the recovery of Fines and Penalties.

III. And be it enacted, That in case the owner or owners of any Cow or Neat Cattle which may be found going at large, contrary to the provisions of this Law, cannot be found, such Cow or Neat Cattle shall and may be impounded until the said penalty and all legal expenses are paid.
