# CAP. XXIX.

An Act to limit the operations of an Act, intituled An Act for the adjustment of claims of certain 12 V. c. 73. purchasers of Crown Lands.

Passed 26th April 1850.

6 WHEREAS it is deemed advisable that a time should be appointed within Preamble. 'which all claims should be preferred under the provisions of an Act 'made and passed in the twelfth year of Her Majesty's Reign, intituled An Act 'for the adjustment of claims of certain purchasers of Crown Lands;'

Be it therefore enacted by the Lieutenant Governor, Legislative Council and Applications for Assembly, That all applications for relief under the provisions of the said recited Act 12 V. c. 73, to Act, shall be made on or before the first day of January in the year of our Lord be made by 1st one thousand eight hundred and fifty one.
