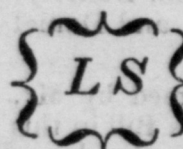

WHEREAS the General Assembly of this Province stands
prorogued to the last Tuesday of this present month of June,
I have thought fit further to prorogue the said General Assembly,
and the same is hereby further prorogued to the second Tuesday
in September next.

seventeenth day of June, in the year of our Lord one
thousand eight hundred and fifty one, and in the
fourteenth year of Her Majesty's Reign.

WHEREAS the Lieutenant Governor of Her Majesty's Pro-
vince of New Brunswick, with the Council and Assembly
of the said Province, did, in the month of March, 1851, pass an Act,
which has been transmitted, entitled as follows, viz:—

No. 2063. An Act to facilitate the construction of a Railway from
Saint Andrews to Quebec.

And whereas the said Act has been referred to the Committee
of the Lords of Her Majesty's Most Honorable Privy Council ap-
pointed for the consideration of all matters relating to Trade and
Foreign Plantations, and the said Committee have reported as their
opinion to Her Majesty, that the said Act should receive Her
Majesty's special confirmation; Her Majesty was thereupon this
day pleased, by and with the advice of Her Privy Council, to
declare Her special confirmation of the said Act, and the same is
hereby specially confirmed, ratified and finally enacted accordingly:
Whereof the Governor, Lieutenant Governor or Commander in
Chief for the time being, of Her Majesty's Province of New Brun-
swick, and all other persons whom it may concern, are to take notice,
and govern themselves accordingly.
