DEATH OF HIS EXCELLENCY THE LIEUTENANT GOVERNOR.

A painful and solemn duty to-day, is to record the death of the Lieutenant Governor, SIR JOHN HARVEY, K. C. B., K. C. H., &c. His Excellency departed this life in the 75th year of his age, on Monday March 22nd, at half-past eleven o'clock, A. M.

On the event being known, both branches of the Legislature. and the City Council, adjourned their meetings for transaction of public business; the two former bodies do not meet again until Monday next.

The melancholy announcement of His Excellency's death, gave painful surprise to the citizens. His Excellency's delicate and declining state of health, for some time past, was known,-but no immediate danger was apprehended.

Lady Harvey's death, some months since, as was remarked at the time, gave a severe shock to her venerable consort. His Excellency himself was fully sensible of this;-he lamented his loss, spoke of its effects, and alluded to the probability of speedy reunion in another state of being.

Her Ladyship was married to His Excellency in 1806; she accompanied him during arduous and high services in various parts of the globe, ministering the advice and consolation and moral support, which trying situations required, and which a true and high-souled woman can give, more adequately than any other earthly friend. No wonder that His Excellency drooped, when she left his household,-and anticipated speedy, similar repose for himself. Nature deals alike with the exalted and the humble, in its sympathies and affections.

His Excellency's first Commission is dated September 1794; since then he served in Holland, on the Coast of France, at Cape of Good Hope, in Egypt, India, and Canada. The estimate placed on His Excellency's military services, may be judged by the honors and rank which he enjoyed, and the high civil posts to which he succeeded.

His Excellency became Lieutenant Governor of P. E. Island in 1836-of New Brunswick in 1837-of Newfoundland in 1841 -and of Nova Scotia in 1846. In each of these Dependencies of the Empire, he well represented the courtesy, dignity, firmness, and fidelity to constitutional liberty, which are so appropriate to British Sovereignty.

Whatever differences may have existed, respecting His Excellency's administration of political affairs, during a peculiarly trying period,-the kindness and liberality of his private character met with general and hearty acknowledgment. His willingness to give towards worthy objects, of every description, was proverbial, -so that parties have been known to be delicate in applying, in consequence of an almost over-readiness and over-liberality in bestowing. His Excellency's punctuality, and devout demeanour, on occasions of public worship, set a good example to those over whom he ruled.
