**H**IS Excellency the Lieutenant Governor, in Council, has been pleased to order, That the Postal arrangement made by the Postmaster General of this Province, with the Postmaster General of the United States, for a local rate of Postage of one penny currency, or two cents, on letters passing between the Frontier Town of Saint Stephen in this Province and Calais in the State of Maine, and also a like rate on letters passing between the Town of Saint Andrews in this Province and Robinson in the State of Maine, be carried into effect so far as relates to letters not exceeding half an ounce in weight posted at one of such Frontier Offices for delivery at the corresponding Frontier Town as above described—the prepayment of such Postage to be optional, and the Postage to be retained by the Country collecting it.
