tors of the same.

To all to whom these presents shall come or may concern:

A PROCLAMATION.

WHEREAS in and by an Act of the General Assembly of
this Province made and passed in the fifteenth year of the
Reign of Her present Majesty, intituled "An Act for establishing
a Tender in all payments to be made in this Province, and for
consolidating and amending the Laws relating to the Currency there-
in;" it was among other things enacted, that the said recited Act
should not be in force until Her Majesty's Royal approbation be
first obtained, nor until a day thereafter to be fixed by Proclama-
tion of His Excellency the Lieutenant Governor, duly published
in the Royal Gazette: And whereas the said recited Act was

specially confirmed, ratified and finally enacted by an Order of
Her Majesty in Council, dated the thirtieth day of June in the
year of our Lord one thousand eight hundred and fifty two;

Now Know Ye, that in pursuance of the provisions of the said recit-
ed Act, I do hereby proclaim and direct that the first day of October
next ensuing, shall be the day when the said recited Act shall be in
force, and the same shall on and after that day be in force accord-
ingly: Whereof all persons whom it may concern, are hereby
required to take notice and govern themselves in accordance there-
with.

WHEREAS the Lieutenant Governor of Her Majesty's
Province of New Brunswick, with the Council and Assem-
bly of the said Province, did in the month of April 1852, pass an
Act which has been transmitted, entitled as follows, viz:—

No. 2142. "An Act to prevent the traffic in intoxicating liquors."

And whereas the said Act has been referred to the Committee
of the Lords of Her Majesty's Most Honorable Privy Council
appointed for the consideration of all matters relating to Trade
and Foreign Plantations, and the said Committee have reported as
their opinion to Her Majesty, that the said Act should be left to
its operation; Her Majesty was thereupon this day pleased, by and
with the advice of Her Privy Council, to approve the said Report:
Whereof the Governor, Lieutenant Governor, or Commander in
Chief for the time being of Her Majesty's Province of New
Brunswick, and all other persons whom it may concern, are to
take notice, and govern themselves accordingly.
